Sir,

In producing herewith arrested accused person namely Dhiraj Yadav (26 Yrs) S/o Amin Yadav of Vill- Belatikun, PS- Jinhara, Dist- Jamui (Bihar) along with seized one Truck (Trailer) bearing Regd. No-JH10BY/3125. I beg to report that today myself along with C/1184 Subhendu Maity, 2) C/1407 Sushanta Goswami and 3) NVF/487 Kirtan Sing Sardar all of Para PS were performing Evening mobile duty by Govt. vehicle heading towards Jhapra more under Para PS area vide Para PS Misc C.C No- 1029 dtd 30.04.2022 and Para PS GDE No- 1129 dtd. 30.04.2022. At about 19.50 hrs, I found at near Jhapra Petrol pump one Truck (Trailer) bearing Regd. No- JH10BY/3125 coming from Purulia side rashly and negligently. We tried to stop him but the driver of the said vehicle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to the local public and other vehicles.

So, I arrested him as he violated sec 279 IPC and 184 M.V Act. at 19.55 hrs. I also seized the vehicle with a view to prosecute him U/S 279 IPC and 184 M.V Act. in presence of witnesses. The whole process of seizure was completed in between 20.05 hrs to 20.25 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 184 M.V Act. may kindly be initiated against Dhiraj Yadav (26 Yrs) S/o Amin Yadav of Vill- Belatikun, PS- Jinhara, Dist-Jamui (Bihar).
