In producing herewith 04 (Four) arrested accused persons namely (1) Noren Sing Mura (40 yrs) s/o Lt. Kartik Sing Sir, Mura of Vill-Pandra, PO-Majhidi, PS-Kotshila, Dist-Purulia, (2) Arjun Das @ Kadu (36 yrs) s/o Upasi Das of Das Para, Deshbandhu Road, Ward No- 01, PS- Purulia (T), Dist- Purulia, (3) Raju Sahis (19 years) s/o Mukesh Sahis of Hari Para near Nistarini College, Ward No- 21, PS- Purulia (T), Dist- Purulia and (4) Samrat Ghatak (31 yrs) s/o Lt Dolgobinda Ghatak of Reni Road near Ghatak Kali Mandir, Ward No- 18, PS-Purulia (T), Dist-Purulia, with following seized articles (1) One Country made improvised fire arms made of iron having butt, body and barrel, partly coated with wood with a butt length 2.9 inch, body length 2.6 inch, barrel length 5.6 inch (2) One live cartridge ammunition with a length of 03 inch upon which OK, 05, 7Z is engraved on percussion cap (3) One bhojali, slightly curved in the middle portion, having a length of 16 inch with yellow butt (4) one iron rod with a length of 44.4 inch slightly curved on the upper portion (5) One rusted iron made cycle chain with a length of 41 inch (6) One yellow torch (7) One 10 feet blue nylon made rope, that today (18.05.2017) at 22:25 hrs I received secret information from a source that a gang of criminals comprising of 06 heads under the leadership of Arjun Das @ Kadu (36 yrs) s/o Upasi Das of Das Para, Deshbandhu Road, Ward No- 01, PS-Purulia (T), Dist-Purulia, being armed and well equipped with deadly weapons etc with a view to commit dacoity at a place probably near Locoshedpara, near Railway Station, Purulia.

Accordingly I informed the matter to I/C Purulia (T) PS over phone and contacted with all night patrolling officers, briefing to all I immediately along with source and C/2366 Anupam Das, C/2345 Debsankar Barik and C/2365 Sourav Sao vide Purulia (T) PS C.C. No. 1239/22 dated- 18.05.2022 and GDE No- 1044 dated- 18.05.2022 left to work out the information by a Govt. vehicle. At 22:45 hrs we reached at the place where the suspected persons were assembled and preparing themselves for committing dacoity. From a distance of about 50 yards we cordoned them. But when we reached nearer they all started to flee away. After a hot chase we could able to apprehend 04 persons and after disclosing our identity we detained them. On a thorough interrogation they disclosed their identity as (1) Noren Sing Mura (40 yrs) s/o Lt. Kartik Sing Mura of Vill- Pandra, PO- Majhidi, PS- Kotshila, Dist- Purulia, (2) Arjun Das @ Kadu (36 yrs) s/o Upasi Das of Das Para, Deshbandhu Road, Ward No- 01, PS- Purulia (T), Dist- Purulia, (3) Raju Sahis (19 years) s/o Mukesh Sahis of Hari Para near Nistarini College, Ward No- 21, PS- Purulia (T), Dist- Purulia and (4) Samrat Ghatak (31 yrs) s/o Lt Dolgobinda Ghatak of Reni Road near Ghatak Kali Mandir, Ward No- 18, PS-Purulia (T), Dist-Purulia and they further confessed that they were assembled with an intention of dacoity at a house at Katinpara, ward no-22,PS-Purulia(T), Dist-Purulia. We searched the above noted persons and following items were recovered from their possession, as (1) One Country made improvised fire arms made of iron having butt, body and barrel, partly coated with wood with a butt length 2.9 inch, body length 2.6 inch, barrel length 5.6 inch (2) One live cartridge ammunition with a length of 03 inch upon which OK, 05, 7Z is engraved on percussion cap both article (1) & (2) from the exclusive possession of Noren Sing Mura (3) One bhojali, slightly curved in the middle portion, having a length of 16 inch with yellow butt from the possession of Arjun Das @ Kadu (4) one iron rod with a length of 44.4 inch slightly curved on the upper portion and (5) One rusted iron made cycle chain with a length of 41 inch both article (4) & (5) from the possession of Raju Sahis (6) One yellow torch and (7) One 10 feet blue nylon made rope both article (6) & (7) from the possession of Samrat Ghatak. So it is crystal clear that they were assembled in that area to commit dacoity and thus liable for punishment U/S 399/402 IPC & 25/27 Arms Act. The above noted accused persons were arrested from 23:25 Hrs to 23:45 hrs maintaining all guidelines of Hon'ble Supreme Court of India and seized the above articles preparing seizure list duly signed by accused persons and available witnesses.

On return to PS, I lodge complainant against(1) Noren Sing Mura (40 yrs) s/o Lt. Kartik Sing Mura of Vill-Pandra, PO- Majhidi, PS- Kotshila, Dist- Purulia, (2) Arjun Das @ Kadu (36 yrs) s/o Upasi Das of Das Para, Deshbandhu Road, Ward No- 01, PS- Purulia (T), Dist- Purulia, (3) Raju Sahis (19 years) s/o Mukesh Sahis of Hari Para near Nistarini College, Ward No- 21, PS- Purulia (T), Dist- Purulia and (4) Samrat Ghatak (31 yrs) s/o Lt Dolgobinda Ghatak of Reni Road near Ghatak Kali Mandir, Ward No- 18, PS-Purulia (T), Dist-Purulia for starting a case U/S. 399/402 IPC & 25/27 Arms Act and also for arranging its investigation.
