Sub: Prayer for starting a specific case against one Chakradhar Hembram (38yrs), S/O- Malinda @ Malindra Hembram of vill-Bindukocha, PS- Puncha, Dist-Purulia (Rider of Hero i-Smart Motor Cycle having Reg.No.-WB56L-0577).

Respected Sir,

With due respect I SI Sunil Kr Banerjee, beg to submit before you that on 30/04/2022 at about 16.05 hrs while myself along with C/1147 Bappaditya Nandi & C/749 Jaladhar Kaibarta were performing naka checking at Dhurfela jungle on Tusugoria-Baragram pitch Road under Puncha PS vide Puncha PS CC No-866 Dated-30/04/2022. During naka checking I found one Motor Cycle having three persons (a rider and two pillion riders) was coming from Tusugoria side towards Baragram dangerously with excessive speed without wearing Helmet. We raised hand and directed him to stop the Motor Cycle but the said Motor Cycle rider, violating the Police Signal and endangering human life by rash and negligently driving the Motor Cycle which may cause accident to the road user any time. Somehow we were able to apprehend him. On interrogation they dilosed their identities as Chakradhar Hembram (38yrs), S/O- Malinda @ Malindra Hembram of vill-Bindukocha, PS- Puncha, Dist-Purulia (driver of Hero i-Smart Motor Cycle having Reg. No.- WB56L-0577) and 1.Uttam Mandi (29 yrs) S/O-Lt Sadhan Mandi of vill-Rangametya PS-Puncha Dist-Purulia & Bijay Sing (39yrs) S/O-Lt Krishna Prasad Sing of vill-Bindukocha PS-Puncha Dist-Purulia pillion riders of the said motor cycle.

Hence on being asked Chakradhar Hembram, driver of the said motorcycle produced his driving license and RC book of the said motorcycle but he failed to produce the insurance certificate and pollution certificate of the said motorcycle. So he committed offence U/S 279 IPC read with section 184/190(2)/194C/194D/196 MV Act 1988 read with MV (Amendment) Act, 2019.

So I seized the said Hero i-smart Motor Cycle having Regd. No- WB56L-0577 as well as the RC and driving license from the possession of above noted rider of the said motor cycle namely Chakradhar Hembram under proper seizure list duly singed by him and other available witnesses and arrested the offending driver namely Chakradhar Hembram (38yrs), S/O- Malinda @ Malindra Hembram of vill-Bindukocha, PS- Puncha, Dist-Purulia, abiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bailable I offered him bail but none were turn up before me. On being asked he refused to undergo to medical check up. So finding no other any alternative way I brought him into PS along with seized articles.

So, I pray before you that a specific case may kindly be registered against the accused namely Chakradhar Hembram (38yrs), S/O- Malinda @ Malindra Hembram of vill-Bindukocha, PS- Puncha, Dist-Purulia (driver of Hero i-smart Motor Cycle having Regd. No- WB56L-0577) under proper section of law.
