Prayer for starting a specific case against one Anantalal Sing (26yrs), S/O- Bijay Sing of vill-Bargoria, PS- Boro, Dist-Purulia (Rider of Honda SP-125 Motor Cycle having Reg.No.-JH05CY-0688).

Respected Sir,

With due respect I Sujoy Kundu, beg to submit before you that on 04/05/2022 at about 15.25 hrs while myself along with ASI Anupam Chand, C/863 Rupchand Pauria & C/749 Jaladhar Kaibarta were performing naka checking at Bulanmuri More on Manbazar-Hirbandh pitch Road under Puncha PS vide Puncha PS CC No-889 Dated-04/05/2022. During naka checking I found one Motor Cycle having three persons (a rider and two pillion riders) was coming from Manbazar side towards Hirbandh dangerously with excessive speed without wearing Helmet. We raised hand and directed him to stop the Motor Cycle but the said Motor Cycle rider, violating the Police Signal and endangering human life by rash and negligently driving the Motor Cycle which may cause accident to the road user any time. Somehow we were able to apprehend him. On interrogation they disclosed their identities as Anantalal Sing (26yrs), S/O- Bijay Sing of vill-Bargoria, PS- Boro, Dist-Purulia (Rider of Honda SP-125 Motor Cycle having Reg.No.-JH05CY-0688) and 1.Tapas Sing (26 yrs) S/O-Madhusudan Sing of vill-Datardih PS-Puncha Dist-Purulia & 2.Akshay Sing Sardar (20yrs) S/O- Lt Swapan Sing Sardar PS-Puncha Dist-Purulia, pillion riders of the said motor cycle.

Hence on being asked Anantalal Sing, driver of the said motorcycle produced RC book, Insurance certificate of the said motorcycle but unable to produce his driving license. So he committed offence U/S 279

IPC read with section 181/184/194C/194D MV Act 1988 read with MV (Amendment) Act, 2019.

So I seized the said Honda SP-125 Motor Cycle having Reg.No.-JH05CY-0688 as well as the RC & Insurance certificate from the possession of above noted rider of the said motor cycle namely Anantalal Sing under proper seizure list duly singed by him and other pillion riders and other available witnesses and arrested the offending driver namely Anantalal Sing (26yrs), S/O- Bijay Sing of vill-Bargoria, PS- Boro, Dist-Purulia, abiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bailable I offered him bail but none were turn up before me. On being asked he refused to undergo to medical check up. So finding no other any alternative way I brought him into PS along with seized articles.

So, I pray before you that a specific case may kindly be registered against the accused namely Anantalal Sing (26yrs), S/O- Bijay Sing of vill-Bargoria, PS- Boro, Dist-Purulia (Rider of Honda SP-125 Motor Cycle having Reg.No.-JH05CY-0688) under proper section of law.
