Respected Sir,

With due respect I SI Chandidas Chakraborty, beg to submit before you that on 22/05/2022 at about 15.45 hrs while myself along with force were performing Special Drive (MV Checking) duty vide Puncha PS CC No-1039 Dated-22/05/2022 at near Badra More under Puncha PS, on Dhadki - Indpur pitch Road. I found one Motor Cycle was coming from Dhadki side towards Indpur dangerously with excessive speed. we raised hand and directed him to stop the Motor Cycle but the said Motor Cycle rider, violating the Police Signal and endangering human life by rush and negligently driving the Motor Cycle which may cause accident to the road user any time. Somehow we were able to apprehend him. On interrogation he made incoherent statement at different time. He disclosed his identity as Raju Mahato (32 yrs), S/O- Mahadeb Mahato of vill:-Pakbirrah, PS- Puncha, Dist-Purulia (Rider of Bajaj Pulsar Motor Cycle having Reg. No-CG-13UC-4951).On being asked he unable to produced RC of above noted motor cycle as well as failed to produce his driving license.

Hence he violated the provision of Section 279 IPC & R/W Section 184/194D/181/192 MV Act 1988. So I seized the said Bajaj Pulsar Motor Cycle having Regd. No- CG-13UC-4951 from the possession of above noted rider of the said motor cycle under proper seizure list duly singed by him and other available witnesses and arrested the offending rider namely Raju Mahato (32 yrs), S/O- Mahadeb Mahato of vill:-Pakbirrah, PS- Puncha, Dist-Purulia abiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court. As the offence is bail able I offered him bail but none were turn up before me. On being asked he refused to undergo to medical check up.
