With due respect In Chandidas Chakraborty, beg to submit before you that on 22/05/2022 at about 12.25 hrs while myself along with C/617 Mrityunjoy Sahana & C/1260 Santosh Soren were performing naka checking at Dhadki More Manbazar- lalpur pitch Road under Puncha PS vide Puncha PS CC No-1038 Dated-22/05/2022. During naka checking I found one Motor Cycle having three persons (a rider and two pillion riders) was coming from Manbazar side towards Lalpur dangerously with excessive speed without wearing Helmet. We raised hand and directed him to stop the Motor Cycle but the said Motor Cycle rider, violating the Police Signal and endangering human life by rash and negligently driving the Motor Cycle which may cause accident to the road user any time. Somehow we were able to apprehend him. On interrogation they disclosed their identities as Susanta Sing (19yrs), S/O- Panchanan Sing of vill-Dhadki, PS- Puncha, Dist-Purulia (driver of Hero Glamour Motor Cycle having Reg. No.-WB56S-4451) and 1) Sudip Dutta (19 yrs) S/O-Sunil Duttta of vill-Dhadki PS-Puncha Dist-Purulia & 2) Soumen Bauri (19 yrs) S/O-Mohan Bauri of vill-Dhadki PS-Puncha Dist-Purulia pillion riders of the said motor cycle.

Hence on being asked Susanta Sing (19yrs), S/O- Panchanan Sing of vill-Dhadki, PS- Puncha, Dist-Purulia, driver of the said motorcycle. On being asked he produce his driving license as well as he unable to produce RC book of the said motorcycle. So he committed offence U/S 279 IPC read with section 184/194C/194D/192 MV Act 1988 read with MV (Amendment) Act, 2019.

So I seized the said Hero Glamour Motor Cycle having Regd.
