Prayer for starting a specific case against one Anup Kr. Mahato (24 yrs) S/O Haradhan Mahato of Vill-Parashibona, PS-Hura, Dist-Purulia (Motor Cycle Rider having Regd. No-WB56S-0235 Blue-Black colour Hero Glamour)

Respected Sir,

With due respect I SI Abhijit Singha, beg to submit before you that on 29.05.2022 at about 09:45 hrs while myself along with force (i) C/624 Pradip Chakraborty & (ii) C/1350 Subodh Bouri were performing Naka Checking duty vide Purulia (M) PS GDE No-1320 Dated-29.05.2022 near at Bandhan Cement Factory on Purulia-Barakar Road (SH-05) under Purulia (M) PS. At that time I found one Motor Cycle was coming from Raghunathpur side towards Purulia Town with 02 (two) pillion rider. Police personnel of Naka party in proper Police uniform raised hand and directed him to stop the Motor Cycle but said Motor Cycle rider violating the Police Signal and endangering the human life rush and negligently driving the Motor Cycle which may cause any time accident to the road user. After that we can able to apprehend them near at Bandhan Cement Factory. On interrogation they made incoherent statement at different times. After that they disclosed their identity as (i) Anup Kr. Mahato (24 yrs) S/O Haradhan Mahato of Vill-Parashibona, PS-Hura, Dist-Purulia (rider of the said motorcycle), (ii) Jagannath Mahato (63) S/O Lt. Sikari Mahato of Vill-Bandhgarh & (iii) Jhantu Mahato (31 yrs) S/O Bhim Mahato of Vill- Hutmura, both of PS- Purulia (M), Dist-Purulia. On being asked rider produce all valid documents in r/o of said motorcycle except Driving Licence. Hence he violated the provision of Section 279 IPC & R/W Section-181/194C MV Act. So I seized the original documents of said Motor Cycle having Regd. No-Regd. No-WB56S-0235 except D.L. at 11:05 hrs to 11:15 hrs under proper seizure list duly singed by the witnesses and arrested the offending rider and 02 pillion rider at 11:20 hrs to 11:30 hrs after observing all formalities and explained the ground of arrest, issued memo of arrest. As the offence is bailable hence, offered them bail accordingly they released on bail after found the surety and fit

So I pray specific case may kindly be registered against the accused rider namely Anup Kr. Mahato (24 yrs) S/O Haradhan Mahato of Vill-Parashibona, PS-Hura, Dist-Purulia (Motor Cycle Rider having Regd. No-WB56S-0235 Blue-Black colour Hero Glamour) for committing offence U/S-279 IPC & R/W Section 181/194C MV. Act.
