Abdul Jamshed, C/ 2366 Anupam Das and LC/ 1197 Farhat Jahan all of Purulia (T) P.S with Govt. vehicle No WB 56D/9024 left PS to the office styled as M.S. Enterprise, D.B.Road near SBI Town Branch, PS-Purulia(T), Dist- Purulia (in the rented house of Nupur Mukherjee w/o Lt. Sanjit Mukherjee of D.B.Road near SBI Town Branch, PS-Purulia(T), Dist- Purulia). At 13:05 hrs we reached at the office and I found that above noted accused persons under the leadership of Subhas Mahata (41 yrs) s/o Aswani Mahata of Vill+PO- Deuli, PS – Santaldih, Dist- Purulia were functioning and busy with forging documents or electronic records to cheat persons with the above noted seized articles. During interrogation with the above noted accused persons, I came to clear that Subhas Mahato and his racket down loaded one on line Recruitment Notice for engagement of computer instructor and trainer and i.e, conducting by Govt. of India. In the recruitment notice found that there is clearly mentioned that education qualification and age of the candidate (i) Degree in Graduate/BCA/MCA from a recognized University/School/Institute (ii) One year computer diploma, but Subhas Mahato and his racket printed a leaflet where the age of the candidate is 18 years and educational qualification of the candidate is minimum is Higher Secondary. This is willfully knowing that everything of the accused persons mercilessly provoking the young un-employed youth and the same time Subhas Mahato and his team misappropriate money day after day to earn money wrongfully. On preliminary discussion with the Subhas Mahato and others it also learnt that Subhas and his associate took shelter near Big Bazar area few years ago and from there they also misguided the youth by various way by giving promise to a job for railway department, Electric department .. and so many an at the same time they misappropriated huge amount of money and thereafter Subhas Mahato and his associates were concealed themselves from the local people due to huge demand of return money as well as promised job. Then 02 years they were totally silent.

Very recent they rented a house near S.B.I Purulia Town branch beside D.B.Road and once again they spread out their nets throughout the Purulia district and giving promise of various Govt. job by the another styled. So, it is crystal cleared that Subhas Mahato alongwith the above noted persons with the help of others is running a cheating business after forging documents with intension to wrongful gain in order to wrongful loss to others.



Hence a specific case may kindly be started under proper section of law against the above noted accused persons and arrange for its investigation.


