I, Tushar Awasthi, S/O Shri Kripa Shanker Awasthi, resident of Dhuniya Para, Ward No-15 of Purulia Municipality, Purulia, West Bengal, would like to state the cause or writing this complaint to you.

Having my shop 'Online Point' at Saheb Bandh road, beside central bank within Purulia town. I hereby lodge my complaint against

Sudip Mukherjee alias Kaltu, son of shyama Prasad mukherjee Member of Legislative Assembly Purulia.

Pradip Mukherjee alais BILTU s/o shyama Prasad mukherjee Dipak Bauri s/o sudhir bouri of Ward No-: 2 Rajesh Mondal s/o kamakha mandal of ward No-: 11

and 3-4 others

On 12<sup>th</sup> of may 2022, at about 8:00 PM IST, while I was inside my said, in the presence of few customers in the said shop, at that time the above mentioned person, all of a sudden came to my said shop and due to previous grudge and enmity against me due to opposite party, the said Sudip Mukherjee

entered my shop and started to abuse me in filthy language. Thereafter, the said Sudip Mukherjee ordered his personal securities to catch hold of me. Following the orders of the said Sudip Mukherjee, they caught and then the said Sudip Mukherjee slapped me repeatedly and with great force on my different body parts for which I sustained grave injuries on my body. The said, Sudip Mukherjee and his securities also ransacked my shop and also have broken some valuable articles causing loss of Rs. 50,000/- approximately.

Hearing the hue and cry, the neighboring people gathered there and then I started a live video on Facebook of the said incident.

After sometime, the above noted miscreants returned to my shop again assaulted me with brick and iron punch on my head and several body parts. They at the same time declared that they came there with intent to finish my life. During the assault I sustained grievous bleeding injury on my head.

During the said assault, the said Sudip Mukherjee declared that 'I have talked with others and make sure that he is dead today' and with such intention they assaulted on my head after which I became senseless.

After the incident, I was taken to the Deban Mahato Government Medical College and Hospital, Purulia for treatment wherein I was admitted at the said hospital as an Indoor patient and as the doctor diagnosed me and found my injury extremely grievous they referred me to higher institution and now fighting for survival.

While, I was being treated at the said hospital, the said Sudip Mukherjee came to the hospital at night

station, in that case they will not spare my life and kill me. I am panic in a panic stricken condition and appeal for help.

presently, I am in the said hospital for which there is some delay in lodging this compliant.

In the circumstances, I fear for my life, as it feels is in danger, I hereby lodge this complaint against the above mentioned miscreants and plead for investigation so that they will be punished properly under the law.
