Sir,

I, the undersigned, with due decorum, would like to apprise your good office, that one Sri Jagannath Das, being the Head Clerk of Nistarini College, Purulia, was entrusted with various vital documents of the college, including the service files of the teaching and non-teaching staff, which was one of such major duties assigned to him for the purpose of the preparation of the service books of the staff of the college. But from the very inception, gross negligence has been observed on his part in preparation of the said service books, particularly in handing over the service books to the undersigned in time, resulting in late pensionary benefits for the retired staff of the college. Such being the backdrop, the undersigned, pursuant to the instructions of the Governing Body (Resolution dated 14/02/2019, agenda 8), asked Mr. Das to hand over all service books, files and papers of all the staff of the college to her. Be it mentioned here that earlier to this resolution, that is, on 23/12/2016, the undersigned also asked the said Mr. Das to submit papers related to attendance register / leave records of the staff, whatever he has in his possession. Despite repeated reminders through different letters so served upon him since then, he has been defying the Governing Body constantly. The matter was brought to the notice of the DPI, Salt Lake, Kolkata, wherefrom necessary directions were given towards initiation of Departmental Proceedings against him.

Due to gross reluctance on the part of the Head Clerk in handing over to the undersigned all files and papers related to the service of the teaching and non-teaching staff of the college, and all college-related documents in his custody, the undersigned had to serve another notice to him on 24/03/2022 over the issue. In pursuance to the request of the said Sri Jagannath Das, it was resolved in the meeting of the Governing Body dated 09/04/2022, that the service files and documents of the teaching staff would be checked and submitted to the undersigned on 18th to 20th April 2022, and those of the non-teaching staff on 21st and 22nd April 2022. It was also decided that, pursuant to the request of Sri Jagannath Das, Prof. Hriday Kumar Mondal, Dr. Rajib Basu (both from the Mathematics department), and Sri Rabindranath Sen (Clerk of the college, and Non-teaching representative in the GB) would undertake the task of checking and listing the service files of all the staff, and it was also resolved that those two teachers would be released from their teaching assignments on these days. Surprisingly enough, Jagannath Das, on 21st and 22nd April, declined to hand over the service books and files of the non-teaching staff, including his own, with

all necessary documents, for submission to the DPI, for his pensionary benefits. Also, from the reports of Prof. Hriday Kumar Mondal and Sri Rajib Basu it transpires that during their checking the contents of the service files of the teaching staff from the Head Clerk, the original service file of the undersigned, and that of Sri Premchand Mondal, were not found, and apart from these, the original joining reports of 8 teaching staff, the original memo from the office of the DPI of the service continuation of Prof. Indrani Ghosh, the original WBCSC letter, vide no 59, dated 24/01/1991 for final absorption (lien free) of Prof. Renuka Gupta, and original approval of appointment of Ms. Lina Pal from the office of the DPI, were not found.

Despite repeated instructions from the Governing Body through the undersigned, Mr. Das has been deliberately withholding the documents of the non-teaching staff, including his own service books and papers, and the report of the said Prof. Hriday Kumar Mondal and Dr. Rajib Basu reveals that he misappropriated the documents of the teaching staff, which will result in serious financial loss of the staff, so to be awarded to them by the Government, for their lifelong service to the institution.

The said Mr. Jagannath Das has illegally taken away the keys of the almirahs, of which there are no duplicates, and the Governing Body remains unable to make him come and hand them over, even after repeated reminders. This is a deliberate act of defiance and insubordination, and also misuse of public property, and the said Mr. Jagannath Das has thereby committed serious criminal breach of trust, and his such conduct, tantamount to application of criminal force, deters the undersigned, being a public servant, from discharging her duties.

It is pertinent to mention that search and seizure is very much warranted in this case.

In the light of the above, it is requested that you may be pleased to take necessary legal steps towards instituting of a specific case, so that the wrong doer may be prosecuted and punished.
