Respected Sir,

I, namely Dillip Kumar Khedia, S/o Late OnKarmal Khedia, C/o Raj Complex, Ranchi Road, Post & P.S & District Purulia would like to ventilate my utmost grievance that on 23/05/2022 around 07:15 a.m. my elder brother namely Rajesh Khedia was coming towards his residence (Mayur Hotel) from Ranchi Road, a goods Carrier (LGV) bearing number JH 09 AY 0260 was coming from the same direction in rash, over speed and negligent manner which hit my elder brother badly from the back side and resulted in death of my elder brother within an hour of the accident at D.M Sadar Hospital, Purulia. The vehicle was in over speed and negligently driven by the driver of the vehicle and the accident took place in ranchi road near the housing gate.

Hence, the reason for delay in complaint is due to the rituals and cremation of the body of my brother. In the above noted circumstances I would like to request you to kindly take necessary action as per law.
