Sir,

I, Sekhar Kr Mitra, Inspector of Police, DEB, Purulia, do here by lodge complaint being produced the following seized articles viz (1) 04 (Four) Pcs. Domestic LPG Cylinder with filling LPG, (a) Sl. No- 205238-B, (b) Sl. No- 572778-T, (c) Sl. No- 423157-T and (d) Sl. No-03461-B All of Bharat Company, (2) 02 (Two) Pcs. Iron made Oven fitted with approx 3 fts. Rubber pipe with plastic made Regulator Valve used for making Tea & Sweets, these articles were used for commercial business at Sweets shop styled as "Satimata Sweets Shop" to the effect that today on 30.04.2022 on the basis of secret and credible information I, along with ASI Swapan Chakraborty, HG/1427 Benimadhab Char & HG/1598 Sunil Kumar all of DEB Purulia had been to Raghunathpur PS and submitted one requisition to I/C Raghunathpur PS for rendering assistance for workout the credible information under the jurisdiction of Raghunathpur PS at 14:45 hrs. which has been noted in GD vide Raghunathpur PS GDE No. 1523 dtd. 30.04.2022 at 15:05 hrs. Thereafter we along with officer and force of Raghunathpur PS (ASI Gurucharan Sahis with Force) left for Kachari more, Ward No 1, Raghunathpur beside on Raghunathpur - Bankura Road (SH-8) under Raghunathpur PS to work out the information. On arrival at the same place at about 15:15 hrs to work out the information and holding raid & search in the sweets shop of one Bablu Roy S/o Ram Naresh Roy of Vill.- Amarkanan, PS -Gangajal Ghanti, Dist.- Bankura at present Kachari More, Ward No 1, PS - Raghunathpur, Dist.- Purulia Styled as "Satimata Sweets Shop" which is located at Kachari more, Ward No 1, Raghunathpur Prior to holding raid in the shop & also visited the business premises of "Satimata Sweets Shop" and noticed 04 (Four) nos. of domestic LPG cylinder kept inside the sweets shop along with apparatus. The owner namely Bablu Roy was using said Domestic LPG Cylinders for preparation of sweets and other commercial activities in his shop which are illegal. He was asked to produce valid documents / license for running his business in respect of possessing such domestic LPG cylinders and also using domestic LPG Cylinders for running business of his sweets shop. But he failed to produce any valid documents / license before me for using such Domestic LPG Cylinders in his sweets shop. Thereafter I seized the above noted Domestic LPG Cylinders and other accessories which he was used for his commercial business after observing all formalities relating to search and seizure in between 15:35 hrs to 16:45 hrs. with proper labeling in presence of owner of the sweets & public witnesses under proper seizure list from the sweets shop of Bablu Roy from his possession.

Hence the sweets shop owner Bablu Roy violated the provisions laid in rule 3 of West Bengal Cooking Gas (Licensing & Control order) 1985 & Regulation of supply and distribution order 2000, Subclause 1(c). Hence the owner of sweets shop has committed an offence punishable u/s 7(1)(a)(ii) of E.C.Act 1955.

In course of local enquiry it revealed that Owner Bablu Roy is running clandestine business of commercial purpose by using LPG Domestic Gas Cylinder instead of commercial LPG since long without having any authority or license and only for causing his wrongful gain and causing loss of revenue to the Govt. and also out of greed to earn more profits and for commercial purpose. Commercial use of Domestic Cylinders is a grave concern in our society and due to this the consumers of domestic cylinders faces various problems including this scarcity of domestic LPG cylinders.

The above noted seized articles as mentioned in S/L No. 01 was left in Zimma to one office deputy manager of M/S Rajdeep Indane, Adra namely Sanjoy Rajak S/o Late Ramu Rajak of Vill.- Subhash Nagar, New Colony, PS – Adra, Dist.- Purulia vide his dealer code no: 230605 in anticipation of kind approval of the Ld. ACJM, Raghunathpur Court, Purulia and other seized articles deposited to PS Malkhana dealing office of Raghunathpur PS.

I therefore request you to start a case u/s 7(1)(a)(ii) of E.C.Act'1955 against accused Bablu Roy S/o Ram Naresh Roy of Vill.- Amarkanan, PS – Gangajal Ghanti, Dist.- Bankura at present Kachari More, Ward No 1, PS – Raghunathpur, Dist.- Purulia.

As per kind order of SP. DEB, Purulia SI Amaresh Das of DEB, Purulia will investigate the case.
