

DATE, TIME & PLACE OF OCCURRANCE.

On 09-04-2022 of the complainant at about 230P.M.

OFFENCE COMMITTED U/S: 341/343/308/379/506/34 I.P.C.

Most respectfully sheweth:-

- 1. That the complainant is the permanent resident of the address as mentioned above having her household thereon with her husband and children.
- 2 .That Sawkat Ali S O Golam Hossain is the legally married husband of the complainant.
- 3. That on the day of incident at relevant point while the husband of the complainant had stepped out from his house the accd. persons attacked him brutally over the issue of an altercation took place before a while. Acced. persons attacked the husband of complainant in furtherance of their common intention to fulfill their oblique motive. Accd. Sabir Ali and Sabnam Bibi assaulted the victim i.e. Sawkat Ali with thehelp of two wooden log ((toward)) over the head, face and other vital of the body. Needless to say another accd. Samima Bibi caughthold the shirt of the victim and inspired other two acced. persons to give blow on the vital part of victim's body which results/the victim in a blood pool condition owing to his severe injury caused by the accd. persons. Blood was oozing out from the mouth of victim. Accd. persons gave out threat to finish the life of victim.

4. That found her husband in such a fatal situation in the hand of accd. person complete and her daughter having no alternative, cried for help to save her husband and came forward to the accd. persons in which the accd. persons left the victim in a dying condition after snatching his mobile handset and currency note amounting approx. 2500/-from the pocket of the victim. Accd. persons also gave out threat to finish the life of complt. and her daughter on any opportunate moment.

5. That the complt. and her daughter got admitted the victim /injured to Raghunathpur superspeciality Hospital on same day owing to the life threatening injury inflicted by accd. person and he underwent a heavy treatment thereon.

6. That from the foregoing paras it is transparent to submit that desperate and neferious act of the accd. persons sufficien—tly attracting section as embodied U/S 308 I.P.C. alongwith other sections as cited above.

7. That the complainant informed the incident to the I/C, Raghunathpur P.S. in writing on 11-04-22 but unfortunate to submit, inspite of that no action has been taken against the accepersons this acce, persons are moving in the locality with their head held high, therefore complainant informed her grevances to the Sapapurulia on 20-04-22 but till date no action has been taken against the acce, persons.

Hence finding no other alternative complainant seeks her remedy before the $^{\rm L}{\rm d}_{\circ}$ court.



Therefore prayed that the Ld. court may kindly be pleased to allow this misc petition with a direction upon I/C Raghunathpur P.S. to sampeand investigate into the matter and take measure against the accd. persons aftertreating this instant petition as F.I.R. as per sec. 156(3) Cr P.C.
