in connection of attacked to CISF duty personnel.

2. It is submitted that CISF No. 911401083 H/O/D
Chandra Mahan Pandey is presently posted at CISF Unit
RTPP Purulia and to day his duty at Ash Pond duty
area. On ~~dated~~ 23-05-2022 about 1330 hrs, he
along with NO 071784356 C/O/D G. C. Jana (CISF staff)
of CISF UNIT RTPP Purulia are on duty at Ashpond
of DVC plant. The following personnel have been
attacked to C/O/D G. C. Jana, thrown stones to
him and he become seriously injured while he
obstruct them to damage the contractor's vehicles
who engaged for DVC plant to Ashpond road (Pabra)
construction. C/O/D G. C. Jana told the name of
following personnel and the incident happened with
him. He also told that these personnel (miscreants)
stole cement bags and also assault the contractor
workers and threatened them. On knowing the
incident local police and CISF QRT party reached
