Sub: Prayer for starting a specific case against Parameswar Rajwar(45 yrs) S/O- Lt. Fakir Rajwar of Vill- Ushir, PS- Santaldih, Dist- Purulia, A/P- Bhojudih Rly. Colony Qtr No. ELC/25/1, PS- Chandankeyari, Dist- Bokaro(Jharkhand), (Driver of Hero Splendor Pro Motor Cycle having Reg.No.- JH10AG/5369).

Respected Sir,

In producing herewith the arrested accused person Parameswar Rajwar(45 yrs) S/O- Lt. Fakir Rajwar of Vill- Ushir, PS- Santaldih, Dist- Purulia, A/P- Bhojudih Rly. Colony Qtr No. ELC/25/1, PS- Chandankeyari, Dist- Bokaro(Jharkhand) and seized motorcycle bearing registration no. JH10AG/5369. I beg to submit regarding the fact of the case in brief is that today i.e on 01.05.2022 myself along with ASI Rabin Mukherjee, C/105 Partha Tewary and C/1183 Subhash Kundu, all are of Santaldih I/C BCW were performing surprise naka checking duty at Gowai river bridge vide Santaldih I/C BCW GDE No. 06 dated 01.05.2022 and C.C No 270 dated 01.05.2022. During naka checking I found one Motor Cycle was coming from Nabagram side driving his motorcycle dangerously with excessive speed, using mobile phone during driving and without wearing Helmet. We raised hand and directed him to stop the Motor Cycle but the said Motor Cycle rider, violating the Police Signal and endangering human life by rash and negligent driving the Motor cycle which may cause accident to the passerby any time. Somehow we were able to apprehend him. On interrogation he disclosed his identity as Parameswar Rajwar(45 yrs) S/O- Lt. Fakir Rajwar of Vill- Ushir, PS- Santaldih, Dist- Purulia, A/P- Bhojudih Rly. Colony Qtr No. ELC/25/1, PS- Chandankeyari, Dist- Bokaro(Jharkhand) (Driver of Hero Splendor Pro Motor Cycle having Reg.No.-JH10AG/5369).

On being asked Parameswar Rajwar, driver of the said motorcycle produced Registration certificate of the said motorcycle but he failed to produce any other documents in respect of the said motorcycle. Thus he committed offence U/S 279 IPC read with section 181/184/194D/196 of MV Act 1988 read with MV (Amendment) Act, 2019. Accordingly I seized the said Hero Splendor Pro Motor Cycle having Reg.No.-JH10AG/5369 and registration certificate from the possession of above noted driver of the said motor cycle namely Parameswar Rajwar under proper seizure list and arrested the offending driver namely Parameswar Rajwar(45 yrs) S/O- Lt. Fakir Rajwar of Vill- Ushir, PS- Santaldih, Dist- Purulia, A/P- Bhojudih Rly. Colony Qtr No. ELC/25/1, PS- Chandankeyari, Dist- Bokaro(Jharkhand), abiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court after issuing check list. As the offence is bailable, I offered him bail but none turned up before me. On being asked he refused to undergo medical check up. So finding no other any alternative I brought him to Santaldih I/C BCW under Santaldih PS along with seized articles.

Therefore I pray before you that a specific case may kindly be registered against the accused namely Parameswar Rajwar(45 yrs) S/O- Lt. Fakir Rajwar of Vill- Ushir, PS- Santaldih, Dist- Purulia, A/P- Bhojudih Rly. Colony Qtr No. ELC/25/1, PS- Chandankeyari, Dist- Bokaro(Jharkhand) (Driver of Hero Splendor Pro Motor Cycle having Reg.No.-JH10AG/5369) under proper section of law and arrange for its investigation.
