To The Inspector-in- Charge Santaldih Police Station

Sir,

In producing herewith the arrested accused persons namely 1) Puna Bouri @ Chhotu(30 yrs) S/O- Lt. Moriram Bouri of Bogra Cinematola, PS- Santaldih, Dist- Purulia 2) Ramesh Rajak (29 yrs) S/O- Tuntun Rajak of vill- Dubra, PS- Para, Dist- Purulia and seized articles. I beg to submit regarding the fact of the case in brief is that on 02.05.2022 at 21:35 hrs received a credible source information that a gang of criminals have assembled at the back side of Santaldih Thermal Power Station (STPS) Plant to commit dacoity at STPS plant . This refers to Santaldih I/C BCW GDE No. 38 dated 03.05.2022. I shared this information to IC Santaldih PS and as per order I along with ASI Rabin Mukherjee, C/105 Partha Tewary, C/1183 Subhash Kundu, C/1337 Laxman Thakur and C/662 Dhananjoy Pandey left to work out the information at 21.45 hrs. This refers to Santaldih I/C BCW GDE No.39 dated 03.05.2022 and C.C No 281/22 dated 03.05.2022. I along with officer and force reached near the back side of STPS plant at 21:55 hrs. Prior to that I briefed officer & force regarding the information and chalked out the plan. We placed ourselves in bushes and ambushed there. Their gossiping talk disclosed their plan for committing dacoity in STPS plant. I along with officer and force reached to their place of assembly by crawling and reached at 30 meters away from the place of assembly of the criminals. Surprisingly the criminals noticed our presence and at once they started threatening us for not to proceed any more before them. We warned them loudly to surrender but they did not listen to us. Suddenly all the criminals started to run towards Belkura side. We chased them and after a hot chase we could be able to intercept 02 (Two) accused persons and rest 5/6 others could be able to flee away and hide themselves in the dark of night. On asked the intercepted accused persons disclosed their identity as 1) Puna Bouri@ Chhotu(30 yrs) of Bogra Cinematola, PS- Santaldih, Dist- Purulia 2) Ramesh Rajak (25 yrs) S/O- Tuntun Rajak of vill- Dubra, PS- Para, Dist- Purulia but they could not be able to recollect the names of other associates. On asked they confessed their guilt and stated that they have assembled there to commit dacoity in STPS plant. Accordingly I arrested both the accused persons after observing all legal formalities. We searched both the arrested accd. persons thoroughly. At the time of searching the following articles were recovered from the arrested accused persons 1. One iron made crowbar of which one side is sharp and another side is blunt, measuring length approx 33 inch and one black colour eveready torch, measuring approx 6 inch recovered from the exclusive possession of arrested accd. Puna Bouri @ Chhotu 2. 02(Two) tenser blades, measuring length approx 12 inch each and one blue colour nylon rope length measuring approx 30 ft, recovered from the exclusive possession of arrested accd. Ramesh Rajak. Accordingly I seized the same under proper seizure list in presence of witnesses duly signed by them. As the place was lonely and time was dark hours of night; no public witnesses were available there.

Therefore I pray before you that a case may be started as per-law and arrange for its investigation.
