In producing herewith the seized tractor styled as Mahindra B275-DI, bearing Registration No. WB81/1115, fitted with trolley (without number plate) loaded with approx 100 Cft. Sand without any Cover. I SI Biswajit Mondal of Santaldih I/C BCW under P.S-Santaldih do hereby lodged a written complaint to the effect that today i.e on 23.05.2022 at 06:45 hrs acting on a tip off myself along with force left towards Gowai river to work out the information. This refers to Santaldih IC BCW GDE No-297, Dated- 23/05/2022 when we reached at Premsingdih village found that a tractor was coming from Gowai river towards Poradih village side. Seeing the Police party driver of the said tractor kept the tractor near Premsinghdih Shiv temple and fled away. We chased the driver but could not be able to intercept him. We reached to the tractor and found that registration no. of the tractor is WB81/1115 styled as Mahindra B275-DI fitted with trolley (without number plate) loaded with approx 100 Cft. sand without any Cover. I searched the tractor thoroughly to find out any valid document in respect of the said tractor as well as sand loaded on it but no any documents could be found. Finding no other alternative I seized the tractor bearing Registration No. WB81/1115 styled as Mahindra B275-DI, fitted with trolley (without number plate) loaded with approx 100 Cft. sand without any Cover in between 07:35 hrs and 07:55 hrs under proper seizure list in presence of witnesses duly signed by them.

Under the above fact and circumstances it could be ascertained that the driver and owner of the above noted tractor are running such clandestine business by illegal transportation of sand without any valid documents for their wrongful gain.

Hence, I, pray, that a specific case may kindly be started against the driver and owner of the tractor bearing Registration No. WB81/1115 styled as Mahindra B275-DI, fitted with trolley (without number plate) loaded with approx 100 Cft. sand under proper section of law and arrange for its investigation.
