In producing herewith arrested accused person namely Anadi Mahato (25Y), S/O Parabhu Mahato, Vill. – Sindurpur, PS – Santaldih, Dist. - Purulia along with seized one Powertrac Euro 439 tractor bearing registration No. WB-82D-6619 along with trolley. I beg to report that today (13.05.2022) I, SI Sajal Kanti Panda along with 1) C/1391 Jayanata Kumar Panda, 2) C/1034 Fakir Chandra Mahato and 3) C/370 Shyamapada Lohar all of Santaldih PS were performing special mobile duty at Santaldih PS area vide Santaldih PS C.C No- 2342 dtd 13.05.2022 and GDE No- 547 dtd. 13.05.2022. At about 17.15 hrs, I reached at Shyampur more and found one tractor (Powertrac Euro 439) bearing registration No. WB-82D-6619 coming from Paharigora side rashly and negligently. We tried to stop him but the driver of the said tractor was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him.
