Sub: Request for lodging F.I.R. against arrested accused person Anadi Mahato (25Y), S/O Parabhu Mahato, Vill. - Sindurpur, PS - Santaldih, Dist. - Purulia.

Sir,

In producing herewith arrested accused person namely Anadi Mahato (25Y), S/O Parabhu Mahato, Vill. - Sindurpur, PS - Santaldih, Dist. - Purulia along with seized one Powertrac Euro 439 tractor bearing registration No. WB-82D-6619 along with trolley. I beg to report that today (13.05.2022) I, SI Sajal Kanti Panda along with 1) C/1391 Jayanata Kumar Panda, 2) C/1034 Fakir Chandra Mahato and 3) C/370 Shyamapada Lohar all of Santaldih PS were performing special mobile duty at Santaldih PS area vide Santaldih PS C.C No- 2342 dtd 13.05.2022 and GDE No- 547 dtd. 13.05.2022. At about 17.15 hrs, I reached at Shyampur more and found one tractor (Powertrac Euro 439) bearing registration No. WB-82D-6619 coming from Paharigora side rashly and negligently. We tried to stop him but the driver of the said tractor was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated sec 279 IPC. I also seized the vehicle along with trolley with proper seizure list in presence of witnesses. The whole process of seizure was completed in between 18.15 hrs to 18.35 hrs. His owner of the tractor was also informed about the ground of arrest.

Hence, I pray that a specific case U/S 279 IPC may kindly be initiated against Anadi Mahato (25Y), S/O Parabhu Mahato, Vill. - Sindurpur, PS - Santaldih, Dist. - Purulia.
