Sub : Prayer for lodging FIR against accd. Sadhan Bouri (35 yrs) S/O – Lt. Bhaktu Bouri of BCW Bus-stand, PS-Santaldih Dist- Purulia U/S 46A (c) B.E. Act 1909.

Sir,


In producing herewith arrested accused Sadhan Bouri (35 yrs) S/O – Lt. Bhaktu Bouri of BCW Bus-stand, PS-Santaldih Dist- Purulia along with 16 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle. I beg to state that today i.e on 13.05.2022 at 17.45 hrs acting on a tip off I along with force had been to the of Sadhan Bouri S/O – Lt. Bhaktu Bouri of BCW Bus-stand, PS-Santaldih Dist- Purulia. This refers to Santaldih I/C BCW GDE No- 163 dated 13.05.2022 and C.C No- 317/22 dated 13.05.2022. I along with force held raid in the house of Sadhan Bouri. Seeing police van some unknown persons coming out from the house of Sadhan Bouri fled away. However I could be able to intercept Sadhan Bouri. On search found 16(Sixteen) bottles country spirit styled as "DIL KHUSH" in his house. Each bottle contains 600 ml of country spirit. I also found approx 46 empty bottles of country spirit styled as "DIL KHUSH" scattered at the courtyard of his house. On asked he failed to produce any valid documents in respect of possessing and selling of country spirit in his house as well as he confessed his guilt. Accordingly I arrested the accd. Sadhan Bouri S/O – Lt. Bhaktu Bouri of BCW Bus-stand, PS-Santaldih Dist- Purulia and seized and labeled 16 bottles of country spirit styled as "DIL KHUSH", each bottle contain 600 ml under proper seizure list in presence of witnesses duly signed by them. Out of seized 16 bottles country spirit 01(One) bottle kept as sample.

However the accd. Sadhan Bouri committed offence U/S 46A(c) B.E Act, 1909 for possessing and selling of country spirit in his house without any valid documents.

Therefore, I pray before you that a case may be started against accd. Sadhan Bouri (35 yrs) S/O – Lt. Bhaktu Bouri of BCW Bus-stand, PS-Santaldih Dist- Purulia under proper section of law.
