

Respected Sir,

In producing here with the arrested accused person namely Ganesh Gorain (36 Yrs), S/O- Lt. Jiten Gorain of Vill- Beltikuri, P.O.- Goswamidih, PS- Saltora, Dist - Bankura along with 150 liters 720 ml Foreign Liquor (Imperial Blue – 52 pcs @ 180 ml each, Mc Dowells No 1(Original Whisky) – 44 pcs @ 180 ml each, Mc Dowells No 1(Celebration (Rum)) - 48 pcs @ 180 ml each, Kingfisher - 16 Packs (12 bottles each pack)) Total value of Rs- 45120/- seized under proper seizure list. I beg to submit that today (05.05.2022) at about 20:15 hrs received a credible source information that one person is coming from Rambhattadih side by a Swift car (WB 68AH 9449) with huge amount of illegal Foreign Liquor.

After receiving this information, I informed the matter to you and as per your direction I left PS to work out this information. Finally I intercepted the white colored Swift car (WB 68AH 9449) at about 20:45 hrs near at Dhekshila more under Santuri PS, Dist.- Purulia and found 150 liters 720 ml Foreign Liquor (Imperial Blue – 52 pcs @ 180 ml each, Mc Dowells No 1(Original Whisky) – 44 pcs @ 180 ml each, Mc Dowells No 1(Celebration (Rum)) - 48 pcs @ 180 ml each, Kingfisher - 16 Packs (12 bottles each pack)) Total value of Rs- 45120/- from the possession of owner cum driver namely Ganesh Gorain (36 Yrs), S/O- Lt. Jiten Gorain of Vill- Beltikuri, P.O.- Goswamidih, PS- Saltora, Dist - Bankura .On demand, he failed to produce any valid documents/ License in respect of keeping and transporting of Foreign Liquor bottles. Accordingly, I seized and labeled 150 liters 720 ml Foreign Liquor (Imperial Blue - 52 pcs @ 180 ml each, Mc Dowells No 1(Original Whisky) - 44 pcs @ 180 ml each, Mc Dowells No 1(Celebration (Rum)) - 48 pcs @ 180 ml each, Kingfisher - 16 Packs (12 bottles each pack)) Total value of Rs- 45120/under proper seizure list duly signed by the witnesses out of which one bottle of each is sealed and labeled as sample and seized the white colored Swift car (WB 68AH 9449). Then, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A (C) B.E. Act 1909 against the arrested accused person namely Ganesh Gorain (36 Yrs), S/O- Lt.
