Sir,

In producing herewith the following seized two nos of Vehicle (type 407) bearing registration No. WB 67B 4669 and WB 37D 9013 loaded with coal 12.75 Ton (approx) in both vehicles and accused (1) Sitaram Kumbhakar, S/O Lt. Dhananjoy Kumbhakar, Vill.- Murlu, PS- Saltora, Dist.- Bankura (Driver of vehicle No- WB 37D 9013) and (2) Ananda Sutradhar, S/O Lt. Nabani Sutradhar, Vill.- Poradiha, PS- Santuri, Dist.- Purulia (Driver of the vehicle No- WB 67B 4669) do hereby lodge complaint to the effect that today on 10.05.2022 at 00:05 hrs, in course of night Mobile Duty, I had information to the effect that 02 nos of vehicle (type 407) bearing no - WB 67B 4669 and WB 37D 9013 loaded with coal 12.75 Ton (approx) in both vehicle as per kata slip were coming from Santuri side towards Raghunathpur side. After receiving the said information we have started NAKA checking duty near Salberia more under Santuri P.S jurisdiction with a view to intercept the said two vehicles. I found the said vehicles were approaching towards raghunathpur side. I stopped the vehicle at 00.15 hours at near Salberia more. I found the said vehicles were loaded with coal 12.75 Ton (approx) in both vehicles . On interrogation the above both accd drivers could not produce any paper in respect of possession & transportation of the coal and in respect of the said vehicles. It is reasonable to believe that the owners, drivers of said vehicles have been transporting said illegal coal by that Vehicles. Accordingly So, I have seized the said two vehicles (Type - 407) bearing registration Nos. WB 67B 4669 and WB 37D 9013 along with loaded coal approx 12.75 Ton (approx) under proper seizure list duly signed by the Police witnesses in between 00:25 hrs to 00:40 hrs, since no Local People was found & none turned up as witness . I have also sealed & labeled approx 01 (one) K.G coal as sample from the both major contrabands .Thereafter arranging public drivers, I brought the seized two vehicles (Type - 407) bearing registration Nos. WB 67B 4669 and WB 37D 9013 loaded with coal at Santuri P.S compound.

I therefore pray before you to lodge a specific case against the owner, driver of the vehicles (Type - 407) bearing registration Nos. WB 67B 4669 and WB 37D 9013 under proper section of law.
