Sub: Complaint against Saiful Mondal (29 Yrs), S/O- Asahak Mondal of Vill- Morar, P.S - Bishnupur, Dist - Bankura to start a cog case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing here with the arrested accused person Saiful Mondal (29 Yrs), S/O- Asahak Mondal of Vill- Morar, P.S - Bishnupur, Dist – Bankura along with 10 liters 200 ml Country Spirit (17 bottle X 600ml) value of Rs- 55 X 17= 935/- seized under proper seizure list. I beg to submit that today (on 13.05.2022) I along with force while performing mobile duty at about 15:05 hrs received a credible source information that one person namely Saiful Mondal (29 Yrs), S/O- Asahak Mondal of Vill- Morar, P.S - Bishnupur, Dist – Bankura is stocking and selling Country Spirit without any valid license near at Muradih Station Bazar under Santuri PS Dist - Purulia. Accordingly, I along with force had been to the spot to work out the source information and held raid there. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person is stocking Country Spirit bottles for sell. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Country Spirit bottles. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S- 46A(C) B.E. Act 1909 and supply one copy to him: Then, I seized and labeled 17 (Seventeen) bottles 'DIL KHUSH" country spirit containing 600ml each bottle and amounting Rs-55/- (Fifty five) each bottle, Total amounting Rs- 935/- under proper seizure list duly signed by the witnesses out of which one bottle is sealed and labeled as sample.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S- 46A (C) B.E. Act 1909 against the arrested accused person namely Saiful Mondal (29 Yrs), S/O- Asahak Mondal of Vill- Morar, P.S - Bishnupur, Dist – Bankura and arrange for its investigation.
