Sub: Lodging FIR for locating a CNCP Girl, i.e., Sk. Sana, regarding

Sir,

In reference to the subject above, I am to inform you that,

- Sk. Sana (17 Years), D/o Sk. Sabir Ali of Baruipur, Padmapukur, Kolkata was rescued by RPF along with a boy namely Priyangshu Paul (17 Years), S/o Prasanta Paul, a resident of Library Road, Dankuni, Hooghly on 04/04/2022 and were handed over to Childline for production before CWC.
- Both of them were produced before CWC on the same day. The CWC released the boy on that very day and handed over to his parent. They decided to release the Girl on the next day subject to the arrival of the Parents / legal Guardians of her and ordered for the short-term placement of the Girl at the ANANDAMATH Home for the night of 04/04/2022.
- In the meantime, a lady who claimed herself as the mother of the Girl along with one other relative reached ANANDAMATH Home that night and on their repeated persuasion, the Matron of the Home released the Girl on production of the documents and undertaking of the lady who claimed herself as the mother of the Girl & that of the Girl herself.
- On the next day, the Girl was contacted for the completion of the legal formalities before the CWC by the Home authority. But the Parents of the Girl submitted an emergency ticket from Hospital over WhatsApp and informed that the Girl was suffering from Chicken Pox and Chikungunya. Hence, they can not produce the Girl before the CWC.
- CWC then sent a letter to the Chairperson, CWC, South 24-Parganas and requested to seek the help of Baruipur Police Station. On 02/05/2022, Chairperson, CWC, Purulia submitted a letter to the District Magistrate, Purulia stating that as per report of the Dy. Superintendent of Police, DEB, Baruipur Police District, no such Girl namely Sk. Sana, D/o of Sabir Ali was found at the given address.

Under the given circumstances, you are requested to kindly arrange for the tracing the Girl so that the legal formalities may be conducted by the CWC, Purulia. At the same time, you are also requested to check the veracity of the documents produced at the time of release of the Girl from ANANDAMATH.

Please treat this as FIR.


