In producing herewith the arrested accused person namely Joydeb Gope (30 yrs), S/o Dhoru Gope of Bittard, PS- Arsha, Dist- Purulia along with copy of seizure list in respect of seized one loaded Trailer , bearing Regd. No- NL02Q 8983 to your good office, I would like to draw your kind attention regarding the fact that today (07.05.2022) at about 10:35 hrs while I was visiting Traffic restrictions Points at Sati Mandir under Tamna PS as for other days, found one Tailer bearing Reg No. NL02Q 8983 coming from Tamna side dangerously with high speed dashed and damaged our Police guardrail used for vehicle restriction at Sati Mandir restriction point and fled away towards Bhatbandh More. After hot chase I was able to detain the vehicle along with its driver at Bhatbandh More. During conversation I felt smell of Alcohol was coming out through the mouth of driver of said vehicle. Accordingly I brought him to our Traffic Office and arranged for his alcoholic test through breath analyser device. The device shows the result as follows.
