

Respected Sir,

In producing herewith one arrested accused person namely Shubnath Gope (40 yrs) S/O- Lt. Ludhu Gope of Vill + P.O- Baligara, P.S- Tamna, Dist.- Purulia with seizure list and seized articles, I beg to submit that today i.e on 13.05.2022 at about 17:25 hrs during Evening/Night mobile duty at PS area vide Tamna PS CC No- 1232/22 date- 13.05.2022 & Tamna PS GDE No- 558 date- 13.05.2022, received a secret source information and as per order of O/C Tamna PS, I PSI Surajit Kr. Das S/O- Samir Kr. Das of Tamna PS along with force had been to Baligara village under Tamna PS at 18:35 hrs and as per indication conducted raid in the house of Shubnath Gope (40 yrs) S/O- Lt. Ludhu Gope of Vill- Baligara, P.O- Baligara, P.S- Tamna, Dist.- Purulia and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession Country Spirit styled as "DILKHUSH". On demand he failed to produce any valid documents in respect of stock and selling of said Country Spirit styled as "DILKHUSH" at his house. As such I seized (i) Twenty Two (22) Bottles of Country Spirit styled as "DILKHUSH" each containing 375 ml. & (ii) one Plastic Bottle of "DILKHUSH" containing 375 ml. as a sample under proper Seizure List in presence of witnesses duly signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Shubnath Gope (40 yrs) S/O- Lt. Ludhu Gope of Vill + P.O- Baligara, P.S- Tamna, Dist.- Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of Country Spirit styled as "DILKHUSH" from his house.

Under the fact and circumstances kindly take necessary lawful action against Shubnath Gope (40 yrs) S/O- Lt. Ludhu Gope of Vill + P.O- Baligara, P.S- Tamna, Dist.- Purulia.
