L ASI Jagannath Rakshit of Tamna PS along with force returned to PS and brought one seized Blue Colour SONALIKA DI 35 Tractor bearing Registration No-WB55A/0185 along with sand (Approx 100 cft.) loaded trolley and lodged this complaint to the effect that on 18/19.04/2022, myself along with i). C/138 Bani Bandyopadhyay and ii). C/1336 Madhusudan Paramanik were performing PS area mobile duty vide Tamna PS CC No. 1284/22 Dated- 19/05/2022. During my mobile duty on 19.05.2022 at about 07:45 hrs received credible source information that one Blue Colour Tractor is lifting sand illegally from Kansai Riverbed at Uchali Sand Ghat under Tamna PS, Dist-Purulia. Accordingly myself along with force left to work out the said source information. Then, we intercepted the aforesaid tractor at Uchali Sand Ghat under Tartina PS. Dist-Purulia at about 08:05 hrs and found that the above noted tractor was tagged with a trolley loaded with sand (approx 100 cft.). But seeing the Police party, driver and others of the tractor fled away leaving the said tractor with sand loaded trolley at Uchali Sand Ghat under Tamma PS, Dist-Purulia village under Tamma PS. We tried to apprehend them but fiziled. So there is every ground to reason to belief that the owner and driver and others of above noted tractor dealing in sand business in clandestine manner. We waited for reasonable time but none came forward and produce any proper, challan or any valid documents related to the said loaded sand of above detained tractor. So, I seized the said Blue Colour SONALIKA DI 35 Tractor bearing Registration No- WB55A/0185 along with sand (Approx 100 cft.) loaded trolley.

I like here to note that the said tractor got stuck into the mud at Uchali Sand Ghat under Tamma PS. Dist-Purulia for which a long time wasted at that place to tackle the situation.

On return to Tamna PS, kept the aforesaid seized tractor attached with sand loaded (Approx 100 cfL) trolley at PS compound and I do here by submitting written complaint before you to start a cog case against the owner and driver and others of the tractor Registration No-WB55A/0185 under proper section of law.
