In producing herewith arrested accused person namely Dharmendra Mahato (21 Yrs) S/O- Sudhir Mahato of Vill+PO -Gopalpur, PS-Pindrajora, Dist- Bokaro, Jharkhand along with one seized Black colour Honda SP 125 Motor Cycle bearing Registration No- JH 09AW/4666.

I, ASI Sudhir Tudu S/O- Lt Jagannath Tudu beg to report that today myself along with C/1509 Animesh Mukherjee and NVF/635 Dhiren Dawn all are of Tamna PS were performing Special Naka Checking duty on Purulia - Manbazar road at Durku more near Tamna Police Station under Tamna PS vide Tamna PS GDE No-937 Dtd- 20.05.2022 at about 17:05 hrs, I found one motor Cycle bearing Registration No- JH 09AW/4666 coming from Purulia side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. Being asked to produce all relevant documents in respect of said Motor cycle he produced all document except Driving License regarding the seized Motor Cycle bearing Registration No- JH 09AW/4666. So, I arrested the above noted accused person after observing all legal formalities regarding arrest as he violated Sec. 279 IPC and 181 MV Act. I also seized the motor cycle in presence of witnesses and informed him and his family members regarding ground of arrest.

Therefore, I pray that a specific case may kindly be started against accused Dharmendra Mahato (21 Yrs) S/O- Sudhir Mahato of Vill+PO -Gopalpur, PS-Pindrajora, Dist- Bokaro, Jharkhand.
