Sir,

It is to inform you that Mr. Debrup Mukherjee is an employee of our concern and he has indulged himself in nefarious activities against our Company by cheating the Company by not settling advances taken for various works of the Company, making breach of trust, fraud, mischief and also defaming the Company in various departments including Government Sectors/ Offices.

Furthermore it can be stated that the name of the esteemed Company has been lowered down by him intentionally. His actions have caused total losses of Rs.50,00,000/- to the Company in terms of dealing with his mischief, fraud, defamation, disservice, false claims made, false complaints made and cheating done with the Company.
