Subject- Chaos by the Local people in Adra, West Bengal area where they detained my truck.

Sir,

I, Amit Jaiswal, a scrap purchaser of south eastern railway over a decade. I write to your esteemed self to express my deep concern over increasing crime at Adra area. As a month before I have purchased 28 pcs of wagon for scrap purpose of a valuation near about 2 Cr. from South Eastern Railway - Adra Division. For cutting the same we have appointed few representatives at Adra area where the wagons were to be loaded. The local gang of the Adra area started disturbing them on the very first day and demander 1.20 lakhs for construction of temple gate. Under the influence of fear one of my representative named Bindu Mehta resident of Bokaro gave 10000/- to them as one of the gang leader named Akhilesh Yadav and his fellow members threatened my representatives and started beating Bindu Mehta for not giving him full amount he asked for with dire consequences and also snatched his bike which he returned back later when a person named Munna Singh requested. But lackadaisical approach to the gravity of the situation on the last day of loading of the consignment from the railway yard they detained my truck for 3 days and also kept the loaded truck key from the driver.

There is an atmosphere of insecurity and fear of local gang in the area. I hope you will look into the matter as it will be more serious for all businessman who further going to work in that area in near future. Thanking you
