In producing herewith the arrested accused persons namely (1) Md. Juned (55 Yrs) S/O Lt. Md. Musha (2) Md. Azauddin (27 Yrs) S/O Md. Jiauddin (3) Abdul Kadir (32 Yrs) S/O Abdul Aziz (4) Md. Aziz (29 Yrs) S/O Lt. Md. Kashim all of Upper Jhariadih (Kamlasthan) (5) Md. Washim (45 Yrs) S/O Md. Khalil of Lower Jhariadih, PS- Adra, Dist- Purulia (6) Goutam Gupta (40 Yrs) S/O Lt. Omprakash Gupta of Chinakuri Bazar, PO-Radhanagar (Railway Colony), PS-Kulti, Dist-Paschim Burdwan, A/P-C/O Rajendra Gupta of Ashram Para, Lower Jhariadih, PS-Adra, Dist- Purulia before you, along with seized articles like board money amounting to RS- 2285/-, 52 nos, of playing cards, from their possession etc. as per seizure list.

I beg to report that on 10.06.2022 at 15:35 hrs, I received secret information that one gambling with huge amount was going on at abandoned room of Kamlasthan during my special mobile duty. Accordingly Linform to I/C Adra PS and as per his direction LS.I Madan Chandra Supakar along with (1) C/2939 Sankujit Singha Mahapatra (2) NVI 903 Giridhari Mahato both of Adra PS (3) C/3+18 Mithun Das (4) C/3212 Anupam Biswas (5) C/ 3131 Suman Dolui (6) JC/1505 Bipadtaran Seth all of District Police Force of Purulia District, vide C.C No- 1923/22 in Govt, vehicles left for Kamlasthan Village to work out the information. At about 15:55 hrs we reached at Kamlasthan very slowly and cautiously approached towards abandoned room where the gambling was reportedly going on. From the outside of the abandoned room we over heard the talking of persons present there and within a few moment it was clear that the persons present there were continuing gaming with playing cards in exchange of money causing wrongful loss to one and wrongful gain to another. After that I directed my associate staffs to cordon the place and within a moment the place was cordoned by Police party. We disclosed our identity and then some persons fled away but we were able to apprehend the above noted persons. Then, I requested them to search myself and my other staff accordingly the persons searched ourselves and found nothing except wearing apparels (Police Uniform with nameplates) and Mobile Phones. After that we asked their identity and the persons disclosed their name and address as noted above. It was found that a huge amount of currency note of different denomination were kept on gaining board (Two piece news paper on the floor) and playing cards were also found. On demand the persons clearly confessed that all of them were doing gambling with playing eards in exchange of cash for wrongful loss to one and wrongful gain to another. After that in presence of police party the board money of Rs 2285/- (Two Thousand Two hundred eighty Five Rupees only) with different denomination, 52nos of Playing cards and Two piece news paper were seized for the gaming board in between 16:15 hrs to 16:45 hrs under proper seizure list duly signed by police witnesses as the place is lonely so I found no public witness.

As such for committing offence punishable u/s- 3 & 4 of W.B.G & P.C Act all the above noted 06 (Six) persons were arrested, issuing arrest memo at 16.45 hrs to 17.55 hrs. After arrest 1 offered them medical treatment but they denied.

Therefore I pray before you that one specific case may kindly be start under proper section of law against the above noted accused persons & others and arrange for its investigation.
