In producing herewith one arrested person namely Samir Bauri (28 yrs) S/O Sudhir Bauri of Vill- Chakalta, PS – Adra, Dist- Purulia along with seized One Blue & White colour Swaraj 834 XM, Tractor bearing Eng. No-331008SZP10068, Chassis Number-MBNAG48ACKTF63942 along with sand loaded Blue & White colour Trolley style as "Biswakarma Transport" without number plate seized under proper seizure list and memo of arrest in respect of the supra person before you.

The nub of the fact in a nutshell is that today 18.06.2022 while I along with force namely 1) C/506 Bhutnath Sing Sarder 2) C/2846 Sankhujit Singha Mahapatra left the PS for performing Evening Petrol duty vide CC No-2004/22 Dated 18.06.2022 and Adra PS GDE No 721 Dated 18.06.2022 in PS area. During my petrol duty, I received a tip off at 18:25 hrs that a suspicious tractor loaded with sand was coming from Kashipur road side towards Adra Town, Purulia. Subsequently, I along with force proceeded towards Wireless More to work out the tip off. While I along with force arrived at Wireless More I asked local people who gathered at that place to become witnesses but none came forwarded and all of them left the place. After that I found that one tractor was coming from Kashipur side under Adra PS. I along with force intercepted the vehicle (Tractor) without registration number plate attached with Blue & White colour Trolley style as "Biswakarma Transport" loaded with sand after placing the guardrail on the road at 18:45 hrs at Wireless More and found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the said vehicle disclosed his name noted in the supra. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of the Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious one to us. It was ascertained that the driver of the said tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle procured the said sand from Darkeswar River at Jamkuri Bali Ghat by fraudulently means or theft by any means for transporting the same to run clandestine business. During interrogation the driver clearly confessed that he habitually deal with the clandestine business and assisting in concealment and disposing voluntarily of stolen sand in a clandestine manner since years, also violating the Govt. notification/order. They also violating the order notification vide DM, Purulia from Riverbed. So I, seized the tractor bearing Eng. No-331008SZP10068, Chassis Number-MBNAG48ACKTF63942 along with sand loaded Blue & White colour Trolley style as "Biswakarma Transport" without number plate under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Samir Bauri (28 yrs) S/O Sudhir Bauri of Vill-Chakalta, PS - Adra, Dist- Purulia after informing the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said tractor to Adra P.S.

Under the above facts and circumstances kindly take lawful action against the driver namely, Samir Bauri (28 yrs) S/O Sudhir Bauri of Vill- Chakalta, PS - Adra, Dist- Purulia and the owner of the vehicle as they committed offence U/S 188/379/411/414/120B IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.
