

Sir.

In producing here with the arrested accused person namely Bikash Mahato (45 Yrs), S/O Lt. Nimai Mahato of Vill-Chhoto Aamla Tora, PO-Sukadali, PS-Sarenga, Dist-Bankura driver of the (TATA 3118 TC, BS-3 Truck) bearing Reg. No WB 33B 7340 and seized one TATA 3118 TC, BS-3 Truck bearing Reg. No WB 33B 7340 loaded with Hard Coke coal (dust).

Fact of the case in brief is that on 19.06.22 myself along with forces, C/568 Madhusudan Rajower and HG/1889 Anil Hembrom both of Adra PS were performing evening mobile duty in Adra PS area vide CC No 2012/22 dtd.19.6.22 at about 19.15 hrs. received a credible source information that the above noted truck loaded with hard coke coal was coming from Raghunathpur side towards Kashipur side receiving such information 1 informed the matter to I/C Adra PS and as per his direction we reached at Raghunathpur to Kashipur pitch road near Jhankai Seni Kali Mandir under Adra PS and waiting there. At about 19.45 hrs, we noticed that one Truck was coming from Raghunathpur side we stopped the said truck and on searching it is found the registration no of the truck is WB 33B 7340 and hard coke coal (Dust) was loaded in the truck. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded coal (Dust). But the driver of the said vehicle could not able to produce any kind of documents in respect of the truck and the coal (Dust). I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious one to us. It was ascertained that the driver of the said truck loaded hard coke coal (Dust) with the owner of the vehicle by illegal means for selling the same to make profit dishonestly and they had been running a clandestine business. As such it is every reason to believe that the driver and owner of the said truck and owner of the said hard coke coal (Dust) are transporting the coal illegally. As such I arrested the accused driver of the above noted truck namely Bikash Mahato (45 Yrs), S/O Lt. Nimai Mahato of Vill-Chhoto Aamla Tora, PO-Sukadali, PS-Sarenga, Dist-Bankura after observing all formalities and narrating him the ground of arrest. I also seized the truck having registration No WB 33B 7340 loaded with hard coke coal (Dust) under proper seizure list in presence of police party duly signed by them.

I therefore pray before you kindly lodge FIR against the arrested acced truck driver Namely Bikash Mahato (45 Yrs), S/O Lt. Nimai Mahato of Vill-Chhoto Aamla Tora, PO-Sukadali, PS-Sarenga, Dist-Bankura and also owner of the truck Reg. No WB 33B 7340 and owner of the seized hard coke coal (Dust) as per law and arrange for its investigation.
