Sir,

In producing herewith arrested accused person namely Subham Tantubai (26 yrs) S/O Sambhunath Tantubai of Vill-Rly qtr no DS/343/A Tagore colony South side A/P Polashkola, P.S- Adra, Dist- Purulia. Along with seized articles (1) One White & black colour Pulsar Motor Cycle bearing Reg. no- WB-82E/1010.

I beg to report that today myself along with C/522 Ruplal Tudu, C/1455 Sudhansu Kuiry were engage in Day Mobile duty performing NAKA duty at Adra-Kashipur Pitch road near Boro Kali Mandir Polashkola under Adra PS, vide Adra PS C.C No-2073/22 dtd.25/06/2022 and Adra PS GDE No-990 at about 12:55 hrs, I found One White & black colour Pulsar Motor Cycle bearing Reg. no- WB-82E/1010. coming from Kashipur side towards Adra side rashly and negligently. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such riding. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.

So, I arrested him as he violated sec 279 IPC and 184 MV Act 1988 at about 13:35 hrs. I also seized the motor cycle with a view to prosecute him U/S 279 IPC and 184 MV Act 1988 in presence of local witnesses and police party. The whole process of seizure was completed in between 13:05 hrs to 13:25 hrs. His family member was also informed about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 184 MV Act 1988 may kindly be initiated against accused Subham Tantubai (26 yrs) S/O Sambhunath Tantubai of Vill-Rly qtr no DS/343/A Tagore colony South side A/P Polashkola, P.S- Adra, Dist- Purulia.
