Sir,

In producing here with one arrested accused namely Ranjit Kr. Ram (32 Yrs) S/O Lt. Iswar Ram of A/P Vill- Sevanagar, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 12 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-60 of each bottle.

I ASI Parimal Tewary of Adra PS do here by lodged a complaint against accused namely Ranjit Kr. Ram (32 Yrs) S/O Lt. Iswar Ram of A/P Vill- Sevanagar, PS-Adra, Dist- Purulia to the effect that on 19/10/20 at about 06:55 hrs received a telephonic information from a reliable source that one Ranjit Kr. Ram (32 Yrs) S/O Lt. Iswar Ram of A/P Vill- Sevanagar, PS-Adra, Dist- Purulia has been stocked of country spirit illegally at his bittel shcp and selling the same to hike price for his personal gain. After getting such information I informed to my O/C and as per his direction I along with force reached at Sevanagar at about 07:35 hrs vide Adra PS GDE No- 723 Dt- 19/10/20. and hold raid in the bittel shop of said Ranjit Kr. Ram and found that the said person selling liquor at his house/ shop and after seeing the Police party some person fled away and said Ranjit Kr. Ram has try to concealed himself but I able to apprehend him with help of accompanied force and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Ranjit Kr. Ram (32 Yrs) S/O Lt. Iswar Ram of A/P Vill- Sevanagar, PS-Adra, Dist- Purulia selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest.

Hence I there for pray that a specific case may kindly be started against arrested accused Ranjit Kr. Ram (32 Yrs) S/O Lt. Iswar Ram of A/P Vill- Sevanagar, PS-Adra, Dist- Purulia under proper section of law.
