Along with seized items i.e. 1. Sword -2 nos., 2. Spear-3 nos., 3. Iron rod-6 nos., 4. brickbats about 10 kg, I SI, Amit Kr Masanta, O/C Arsha PS do hereby lodged complaint Suo-motu against the arrested 24 persons and unknown 250/300 unruly mob of Hindu & Muslim community of Sirkabad area to the effect that on 13.06.22, one tension cropped up at Sirkabad village between Hindu & Muslim communities regarding an objectionable Facebook post by Selim Ansary belongs to Muslim community. Over that, 02 cases (case & counter case) were started at Arsha PS (vide Arsha PS Case No. 81/22 dated 13.06.22 U/S 153/153A/2954A/505(2)/506 IPC & Arsha PS Case No. 82/22 dated 13.06.22 U/S 147/149/448/323/379/427/506 IPC). Since then, a tension was prevailing at Sirkabad village and surrounding area.

Today (14.06.22) at about 17:15 hrs, about 100/150 unruly mob of both community being armed with deadly weapon, sword, spear, Lathi, iron rod etc, from each community again assembled near Sirkabad Hospital morh with a view to attack each other. The police personnel though did their best to remove the unruly mob from the place, the mob started pelting stones against each other. The mob scuffled the police personnel in order to prevent them from discharging Govt. duty. They even damaged Govt. properties like two guard rails on road and abused the on-duty police personnel.

Police tried to pacify them, but the mob did not pay any heed to the order of police. The situation was then going out of control and it already formed an unlawful assembly. In the mean time, re-enforcement was made from district Head Quarters. Then with the help of senior police officers, the untuly mob could be dispersed for the time being.

After half an hour, the mob from both sides again assembled at Sirkabad Hospital morh and this time they appeared to be more violent. Some of the members of the mob assaulted the on duty police personnel with a view to kill by throwing heavy sharp cutting sword aiming to me but somehow I averted the attack. SI Uttam Mondal and ASI Tapan Mahato of Arsha P.S. were scuffled and they got injury. I apprehended more imminent violence could erupt. Finding no other alternative, I under the guidance of superior officer declared the mob as unlawful and also ordered to disperse immediately. It is worth mentioning that, no executive magistrate could be made available. But, the mob was not in a mood to disperse. Then we chased the mob and could manage to apprehend the above noted 24 accused persons from whose possession recovered weapon of offence as described in the seizure list prepared in presence of witnesses.

Preliminary enquiry suggested that the following persons have been involved in the mob along with above noted arrested persons-

1. Arup Kuiry, S/O Mukti Kuiry, 2. Mrityunjoy Bhattaraj, 3. Ranjit Mondal, 4. Jhola Bagdi s/o Bholanath, 5. Shibnath Kuiry S/O Kalosona Kuiry, 6. Sashtipada Kuiry S/O Ratul Kuiry, 7. Abagar Ansary s/o Golam Ansary, 8. Munna Ansary S/O Samsad Ansary, 9. Gadai Ansary S/O Chhutu Momin, 10. Sultan Ansary S/O Dusa Ansary were involved in the incident and 250/300 others.

In the circumstances, I started the case against the arrested accused, 10 named and 250-300 unknown persons, vide Arsha PS case No 83/22 dated 14.06.22 U/S 147/148/149/353/186/307/333/120B IPC r/w sec 25 Arms Act, 3 of PDPP Act & 9 MPO Act.
