Sub: To lodge FIR against owner and driver of One Sonalika (DI-42 RX) Tractor without reg. No. having Eng. No. 3100EL1831768083F3 & chassis no. DZYSG776619S3 along with trolley (sand approx 60 CFT each trolley)

Sir,

In producing herewith, 01 One Sonalika (DI-42 RX) tractor having Eng. No. 3100EL1831768083F3 & chassis no. DZYSG776619S3 along with trolley (sand approx 60 CFT each trolley). Today on 26.06.2022 at about 08:25 hrs. acting on source information, I SI Uttam Kr. Mandal of Arsha PS along with (i) C/-238 Dipak Bagti and (ii) C/-1193 Manoranjoan Bhuiin both of Arsha PS, left for PS area vide GDE No. 1049/22 Dtd. 26.06.2022. After we reached at Gouradag Ghat under Arsha PS at 09.35 hrs, we conducted raid on the Bank of River Kansai under Arsha PS and found that 01 (one) tractor along with trolleys attached with by a hinge was present at Gouradag Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Gouradag Ghat, fled away. Police rushed to the Tractor and detained the said tractor. Police searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the person & driver of said offending tractor. Hence, I seized the above noted tractor along with trolley and brought the tractor to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor vide along with the trolley for investigation.


