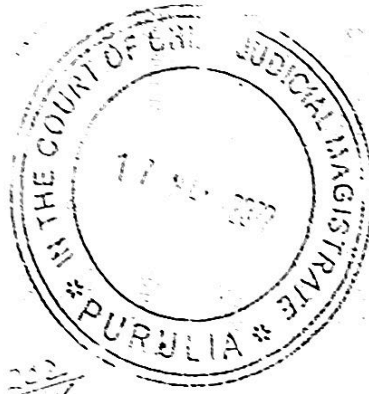

- 1) That your complainant is a permanent resident of village – Telidih, Post- Satra, P.S – Purulia(M), Dist- Purulia (W.B) within the Jurisdiction of this court.

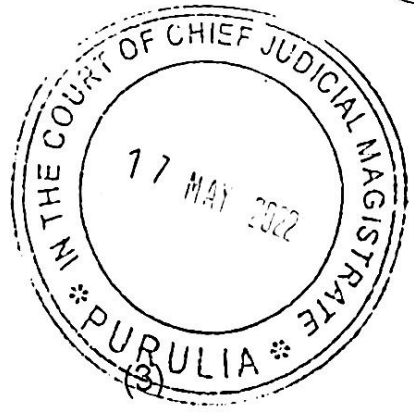

- 2) That Uttam Gope (Now deceased) was the son of your complainant.
- 3) That the accused Dahananjay Gope, S/o Sudhir Gope is the driver cum owner of the motor cycle (Hero Splendor Plus) being Registration No. - WB56R/4947.
- 4) That on 05.12.2021 at about 1:00 P.M when your petitioner's son Uttam Gope ride on a motor cycle of Dhananjay Gope was returning from Senbona hat towards his house at village- Telidih and when the motor cycle reached at the more of Rashiktard due to rush and negligence driving by the driver Dhananjay Gope it lost the control over the motor cycle and as a result the said motor cycle skid and falled on the pitch road near Rashiktard and your petitioner's son fell down from the said motor cycle on the pitch road and sustained serious head injury at that time due to sudden stuck on his head when fell down over the pitch road.
- 5) That due to rush and negligence driving of the motor cycle driver Dhananjay Gope your petitioner's son Uttam Gope (since deceased) sustain severe injuries on his head with profuse bleeding and become senseless and he was taken to purulia Deben Mahato Sadar Hospital with the help of the some local people and there after sadar hospital refer your petitioner's son for batter treatment to Rajendra Institute of Medical Science, RIMS at ranchi on 05.12.2021 where he was treated but expired on 10.12.2021 at about 9:20 A.M.
- 6) That there after postmortem of the dead body of your petitioner's son Uttam Gope was held on 10.12.2021 at about 4:45 P.M by Dr. Lawanya Ekka Junior Resident Non Academic department of FMT, RIMS Ranchi who gave his/her opinion that the cause of death is due to head injury and its complication.

- 7) That your Complainant being the father of the deceased reported the matter to the Arsha Police Station but no action has yet been taken though the death of his son caused due to rush and negligence driving of the driver / accused of the Dhananjay Gope to committed the offence which has been punishable U/S – 279/304 (A) IPC.
- 8). That your complainant being the father of the deceased reported the matter to the superintendent of police post and district – Purulia on 04.05.2022 about the alleged offence occurred by the accused Dhananjay Gope but no action has yet been taken from his end.
