In producing herewith arrested accused person Dhananjoy Mahato (24 Years) S/O- Nagen Mahato of Vill- Nimetare, PS – Purulia (T), Dist – Purulia along with seized article i.e. (1) One Black Colour 'Honda Shine' Motor Cycle having Registration No. WB 56T/1900.

I beg to report that today myself along with C/15 Susanta Kr. Dey and C/238 Dipak Bagti both of Arsha PS were performing Naka Checking duty at Palpal More under Arsha PS area vide Arsha PS C.C No – 1330/22 dtd. 29.06.2022 and Arsha PS GDE No – 1175 Dtd 29.06.2022. At about 12.15 hrs, I found one Black Colour 'Honda Shine' Motor Cycle having Registration No. WB 56T/1900 coming from Aharrah side towards Begunkodar rashly and negligently without wearing helmet. We try to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss / serious injury of nearby public due to his such riding. After a hot chase we could able to stop him at Palpal More under Arsha PS. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life.
