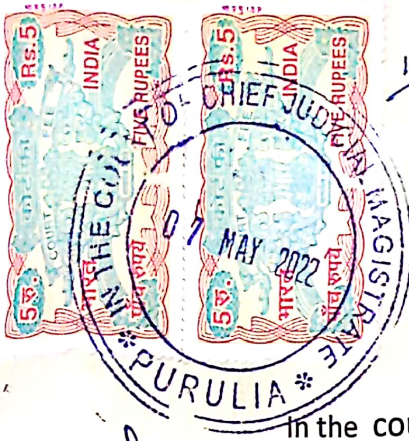

5. Offences :- U/S

The above named complainant begs to state  
as follows:-

1---- That your petitioner is the legally married wife of accused Madhusudan Mahato . The parties are Kurmi Mahato by caste and Hindu by religion . Their marriage was solemnised on 01-07-2018 , according to their customary rites and formalities prevalent in their community. The Marriage is duly consummated and the marriage tie between them .

2----That at the time of marriage , as per demand of the accused persons , father of the petitioner had to give considerable dowry including a hard cash of Rs.25000/-one Hero Honda Super Splendor Motor Cycle , ,2 Bhoris gold, utensils, Palanka, ,bedding etc. to the accused persons but the accused persons were not satisfied with the same .

3----That after marriage the petitioner had been to her matrimonial home with a lot of hope and started to live there as husband wife in a joint mess consisting of her parents in laws , Debar, Nanad, maternal aunt for 10/12 days or so thereafter her husband in collusion with his parents , maternal sister , , brother in law and maternal aunt started a fresh demand of Rs. 100,000/- form her father and asked to bring the same from her father . The accused persons also asked the petitioner to convey their demand to her father and she must bring the same otherwise she would have no place in their hose they threatened . Accordingly your petitioner convey the fresh demand of the accused persons to her poor father who was very much surprised and shocked and expressed his inability to meet the huge demand.

4----That when the money as demanded by the accused persons was not given by the poor father of the petitioner , all the accused persons became furious and vindictive towards the petitioner and started to various mental and physical tortures upon the petitioner without any fault .Off and on she was assaulted by accused Madhusudan Mahato at the ill advise of the other accused persons . She was denied square meal by her mother in law, Nanad and maternal aunt Kalo Mahato and compelled her to do the entire work of the family from dawn to dusk . She was treated as a unpaid maid servant and denied any rest to her . The accused Laxmi Mahato, Paru Mahato and Kalo Mahato started to poisoned the ear of her husband and insists him to beat the petitioner .The petitioner was help less at the hand of the accused persons .

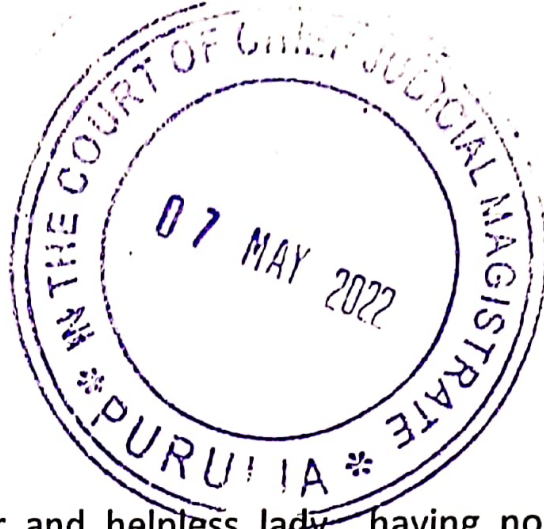
5----That being a devoted Hindu wife , your petitioner had to bears those tortures, cruelties, assault patiently on the hope that her husband and other in laws would mend themselves and would be normal towards her but her hope was never materialised and became shattered . Day by day the volume of tortures, cruelties, and assault were gradually exercised upon the petitioner by all the accused persons which were unbearable and beyond description .

5----That over the issue of fresh demand , there was frequent hot altercation in between the petitioner on the one side and the accused persons on the other and on 01-06-2019, her husband started to assault the petitioner mercilessly , the accuse persons put out the iron bungle from her hand , wipe the sindur from her head and rached the petitioner to her father`s house and fled away . After two / three days i.e. on 03-06-2019 ,her father again reached the petitioner to her matrimonial home but the accused persons did not allow the petitioner to enter the house . At the intervention of the local panches the accused persons reluctantly agree to keep the petitioner in their house and undertake before the local panches that they would not tortures the petitioner any more . In spite of the undertaking given by the accused persons before the local panches , the accused persons again resume their old habit of tortures and assault upon the petitioner . All the accused persons all along exercise their torture and assault mercilessly upon the petitioner which were beyond description .

7----That it may be mentioned here that on the night of last Kalipuja the accused entered in to a criminal conspiracy and hatched a plan to finish the petitioner forever , all the accused persons placed a Pillow over her mouth and tried to kill the petitioner . Your petitioner any how make alarm and saved her life on that moment . On the next morning all the accused persons again started to assault the petitioner mercilessly and drove out the petitioner from their house .Under compulsion the petitioner take shelter in the house of her father at village Hurumda under P.S. Baghmundi .

6----That though the complainant / petitioner reported the matter to the local Police Station but the police was found evasive to take legal action against the accused persons best known to them . Thereafter , your petitioner knocked the door of the Superintendent of Police Purulia on 19-04-2022, but of no good though the accused persons have committed the offences of attempt to murder the petitioner , cause persistent mental and physical and mental tortures, cruelty and assault to the complainant and the accused persons in furtherance of their common intentions have committed the offences of intentionally cause hurt to the complainant .
