4. Occurrence :- 29-05-2008 and on wards particularly on 13-05-2018 and 05-10-2021 which is continuing till date .

5. Offences :- U/S

The above named complainant begs to state

as follows:-

1---- That your petitioner is the legally married wife of accused Anil Mahato . The parties are Kurmi Mahato by caste and Hindu by religion . Their marriage was solemnised on 29-05-2008 , according to their customary rites and formalities prevalent in their community. The Marriage is duly consummated and out of their wed lock a female child is born to them .The marriage tie between them still subsists .

2----That at the time of marriage , as per demand of the accused persons , father of the petitioner had to give considerable dowry including a hard cash of Rs.1,80,000/-, ornaments , utensils, Palanka, bedding etc. to the accused persons but the accused persons were not satisfied with the same .

3----That after marriage the petitioner had been to her matrimonial home with a lot of hope and started to live there as husband wife in a joint mess consisting of her parents in laws , Debar, Nanad, maternal uncle and aunt for 2/3 months or so thereafter her husband in collusion with his parents , sister , , brother and maternal uncle and aunt started a fresh demand of Rs. 50,000/- form her father and asked to bring the same from her father . The accused persons also asked the petitioner to convey their demand to her father and she must bring the same otherwise she would have no place in their hose they threatened . Accordingly your petitioner convey the fresh demand of the accused persons to her poor father who was very much surprised and shocked and expressed his inability to meet the huge demand.

4----That when the money as demanded by the accused persons was not given by the poor father of the petitioner , all the accused persons became furious and vindictive towards the petitioner and started to various mental and physical tortures upon the petitioner without any fault .Off and on she was assaulted by accused Anil Mahato at the ill advise of the other accused persons . She was denied square meal by her mother in law, Nanad and maternal aunt Shanta Mahato and compelled her to do the entire work of the family from dawn to dusk . She was treated as a unpaid maid servant and

denied any rest to her . The accused Salita Mahato, Chandmoni Mahato and Shanta Mahato started to poisoned the ear of her husband and insists him to beat the petitioner .The petitioner was help less at the hand of the accused persons .However your petitioner gave birth to a female baby at this , the accused persons became furious and vindictive towards the petitioner and started to exercise inhuman mental and physical tortures and assault upon the petitioner .

5----That it may be mentioned here that the accused persons are hail from a backward society and according to them birth of a female child is a curse in the family. When the petitioner failed to give birth of a male child , she was taken to task and the accused persons blame the petitioner that she is solely responsible for gave birth of a female baby . The accused Anil Mahato and his other inmates openly spoke out that they would give second marriage of accused Anil Mahato with another lady as the petitioner failed to give birth of a male baby .

6----That being a devoted Hindu wife , your petitioner had to bears those tortures, cruelties and assault patiently on the hope that her husband and other in laws would mend themselves and would be normal towards her but her hope was never materialised and became shattered . Day by day the volume of tortures, cruelties, and assault were gradually exercised upon the petitioner by all the accused persons which were unbearable and beyond description .

7----That over the issue of fresh demand , there was frequent hot altercation in between the petitioner on the one side and the accused persons on the other and on 13-05-2018, her husband started to assault the petitioner mercilessly and drove her out from her matrimonial home . After two / three days her father and one Manohar Modak again reached the petitioner to her matrimonial home but the accused persons did not allow the petitioner to enter the house . At the intervention of the local panches the accused persons reluctantly agree to keep the petitioner in their house and undertake before the local panches that they would not tortures the petitioner in any way any more . In spite of the undertaking given by the accused persons before the local panches , the accused persons again resume their old habit of tortures and assault upon the petitioner . All the accused persons all along exercise their torture and assault upon the petitioner which were beyond description .

8----That it may be mentioned here that the petitioner again conceived for the second time. Having come to know the second pregnancy of the petitioner her husband at the instance of the other accused persons kicked on the belly of the petitioner causing profuse bleeding and causing abortion of the baby in her womb. The petitioner was saved any how but her pregnancy was miscarriage by such heavy kick on her belly. Thereafter all the accused persons again started to assault the petitioner mercilessly and drove out the petitioner from their house .Under compulsion the petitioner take shelter in the house of her father at village Koreng under P.S. Baghmundi .

9----That it may be mentioned here that in the mean time her husband Anil Mahato married for the second time with a lady and took her in his house and leads happy conjugal life with hissecond wife

10----That though the complainant / petitioner reported the ordeal faced by her in the hand of the accused persons to the local Police Station 21-10-2021 but the police was found evasive to take legal action against the accused persons best known to them . Thereafter , your petitioner knocked the door of the Superintendent of Police Purulia on 22-11-2021, but of no good though the accused persons have committed the offences of causing abortion , cause persistent mental and physical tortures, cruelty and assault upon the complainant and the accused persons in furtherance of their common intentions have committed the offences of intentionally cause hurt to the complainant .

11----That the complainant is a very poor and helpless lady having no source of income whatsoever . She is not in a position to conduct the case on her own expenses . Moreover , there are some technical and legal aspects involved in this case which also requires considerable money and machinery . For all these , it is highly desirable that this case should be converted to a police case.

It is prayed that your Honour may be graciously

Pleased to direct the Officer In Charge Baghmundi Police Station to investigate the case in accordance with law , treating the same as F.I.R. , as contemplated U/S 156(3) Cr.P.C.
