I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Bhabataran Kumar S/O Abani Kumar of village Torang , Krishto More, P.S.- Bagmundih, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 28.06.2022 at about 11.00 AM. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundi CCC along with 1. Sri Abdul Hasib., A.C.M., Bagmundih CCC 2. Sri Prabir Adhikary,O.S.H., Bagmundih CCC entered the premises of Sri Bhabataran Kumar S/O Abani Kumar of village Torang , Krishto More, P.S.- Bagmundih, Dist- Purulia and found Sri Bhabataran Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.35 KVA. As Sri Bhabataran Kumar S/O Abani Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1.
