Sir,

In producing herewith one seized red colour Mahindra B275 DI tractor having Chassis No-MBNABAEXKLJC02312, Engine No- NLB2EMJ0043, Reg No-WB55B/3221 along with sand loaded trolley under proper seizure list, I beg to submit that today on (29.06.2022) I along with (1) C/2826 Rodyot Guli, (2) C/2228 Pradip Lohar, (3) C/1445 Bholanath Mistry of Suisa OP under Baghmundi P.S were performing special mobile duty vide Suisa OP CC No-624/2022, Date-29.06.2022. During my special mobile duty at about 17:45 hrs I received a source information that a suspicious tractor loaded with sand was coming from Marcha side. I informed this matter to I/C Suisa OP and after getting necessary permission I along with force left for the said place. While I along with force arrived at Simali village More at 18:05 hrs, found that one tractor was coming from Marcha side and seeing the Police party the driver of the said tractor fled away leaving the said tractor. Due to the darkness and the topography, the driver of the said vehicle somehow managed to escape in a suspicious manner. Due to such suspicious activity of the driver it was ascertained that the driver of the said tractor loaded the sand with the consent of the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and he had been running a clandestine business, hence it is reasoned to belief that the driver of the vehicle procured the said sand from Subarnarekha river bed by fraudulently means or theft by any means for transporting the same to run clandestine business along with the owner of the vehicle. Hence, I seized the tractor vide Chassis No- MBNABAEXKLJC02312, Engine No- NLB2EMJ0043, Reg No-WB55B/3221 along with sand loaded trolley in between 18:45 hrs to 19.05 hrs under proper seizure list duly signed by witnesses. I brought the said sand loaded tractor to Baghmundi P.S compound as such there is every reason to believe that the driver and owner of the vehicle with ill motive dealing with sand illegally without any valid document. So they are liable for offence punishable U/S- 379/411/414/34 IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case may kindly be started and arrange for its investigation against the owner of the said vehicle.
