With due respected I Nitesh Kr. Chowdhary S/O- Sashinath Chowdhary of 14/C Klyan Nagar Bhuinadih, PS-Sitaramdera, Dist-East Singhbhum Jharkhand beg to state that today (31.05.2022) at about 1.30 hrs my brother namely Mukesh Choudhury (36 yrs) S/O-Sashinath Chowdhary of 14/C Klyan Nagar Bhuinadih, PS-Sitaramdera, Dist-East Singhbhum Jharkhand coming from Purulia side to Jamshedpur by driving with his own big trailer typed truck bearing Reg. No- JH05BK/4041 through NH-32. When he reached near at Chhotourma Hattala under Balarampur P.S, Dist-Purulia at that time another trailer typed big truck coming from Balarampur side to Purulia with rash and negligent driving by the driver of the said vehicle bearing Reg. No-NL01AD/5697 and dashed my brothers vehicle from front side due to rash and negligent driving by the driver of vehicle No-NL01AD/5697. As a result my brothers vehicle has been totally damaged and my brother namely Mukesh Choudhury received serious fatal and fracture type head injury. Local people as well as passers driver of the others vehicle shifted him at local Banshgar Hospital where attending M.O declared him death after proper examination.

Due to rash and negligent driving by the driver of said offending vehicle bearing Reg. No- NL01AD/5697 my brother died and my brother's vehicle has been damaged. So kindly take lawful necessary lawful action against the accused driver of the offending vehicle bearing Reg. No NL01AD/5697.
