Respected Sir,

In producing here with the arrested accused person namely Shibu Gorai (age-48 yrs approx) S/O-Lt. Paran Gorai of Vill. Bara Karmo, P.S. Bandwan, Dist. Purulia along with seized Illicit Distill liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 25/06/22 at about 16:55 hrs. I received a credible source information while I was engaged in Evening Mobile duty that one person namely Shibu Gorai S/O-Lt. Paran Gorai of Vill. Bara Karmo, P.S. Bandwan, Dist. Purulia is selling Illicit Distill liquor without any valid license from his dwelling house at Bara Karmo village, P.S. Bandwan, Dist. Purulia. Accordingly, I along with force (C/1224 Gajan Murmu & C/340 Baman Das Goswami both are of Bandwan P.S., Dist-Purulia) vide Bandwan P.S. C.C. No. 2228/22 Dtd: 25/06/22 left for Bara Karmo village under Kuilapal G.P to work out the said source information and held raid at his courtyard where the above mentioned accused person was selling illicit liquor. During search with the help of accompany force, we found that the said person is stocking Illicit Distill liquor for sell. Being asked, he disclosed that all liquor has been stocked for the purpose of sell. On demand, he failed to produce any valid documents/ License in respect of stocking and selling of Illicit Distill liquor. Accordingly, I seized all the Illicit Distill liquor (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses. Approx 15 liters Illicit Distill liquor has been seized in a plastic Jar and 350 ml. Illicit Distill liquor has been kept & labeled as sample bottle. Then, I arrest him after preparing proper arrest memo as he committed offence U/S-46A (a) (c) B.E. Act 1909 and supply one copy to him. I would like to mention here that the customers were fled away seeing the Police party.

Under the above circumstances and fact, I therefore pray that a Cog. case may kindly be started U/S-46A (a) (c) B.E. Act 1909 against the arrested accused person namely Shibu Gorai (age-48 yrs approx) S/O-Lt. Paran Gorai of Vill. Bara Karmo, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
