

Sub: Complaint against Gour Mahato (25 Yrs) S/o- Purna Chandra Mahato of Vill-Tumrasole, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Gour Mahato (25 Yrs) S/o-Purna Chandra Mahato of Vill- Tumrasole, PS- Barabazar, Dist- Purulia and seized one Plastic Jarokin containing about 09 (Nine) Liters liquors (Cholai) on which half liters taken as sample from said Jarokin as per enclosed seizure list.

I, ASI Dipak Das of Barabazar PS do here by lodge this complaint against Gour Mahato (25 Yrs) S/o- Purna Chandra Mahato of Vill- Tumrasole, PS- Barabazar, Dist-Purulia. I beg to state that on 10.06.2022 myself along with C/- 664 Sahebram Saren & C/-1187 Samar Kanta Maity were left for evening mobile duty vides Barabazar PS GDE No- 556 Dtd. 10.06.2022. During mobile duty at about 18.45 hrs I received an information that one person was selling liquor in his house at Vill- Tumrasole under Barabazar PS. I was there to verify the credibility of that information and immediately informed to the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said place to work out the information. At about 19.05 hrs myself along with force held raid in the dwelling house of Gour Mahato at Vill- Tumrasole and found that he was selling Liquor (Cholai) from his house. Seeing the Police party buyers fled away, but we apprehended the house owner who was selling the Liquor. On search I found one Plastic Jarokin containing about 09 (Nine) Liters (Cholai) on which half liters taken as sample from said Jarokin in his dwelling house. On demand, he failed to produce any valid documents / License in respect of keeping & selling liquors (Cholai). On being asked he confessed his guilt and stated that he selling the liquors (Cholai) from his house to the local people with intent to make his own profit. He disclosed his identity as Gour Mahato (25 Yrs) S/o- Purna Chandra Mahato of Vill- Tumrasole, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for keeping or selling of liquors (Cholai). Accordingly, I seized the above noted Liquor after preparing proper seizure list and put label on the seized articles in presence of witnesses and on which half liters taken as sample from said Jarokin which were also duly labeled by me and also took signature of the accompanying witness on seizure list and label as well as accused person also. The seizure and label was done in between 19.25 hrs and 19.45 hrs. Thereafter, I arrested the accused person namely Gour Mahato (25 Yrs) S/o- Purna Chandra Mahato of Vill- Tumrasole, PS- Barabazar, Dist-Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed him and his relatives regarding the ground of arrest over mobile. The arrest was made on 10.06.2022 at 19.55 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Gour Mahato (25 Yrs) S/o- Purna Chandra Mahato of Vill- Tumrasole, PS- Barabazar, Dist- Purulia under proper section of Law.
