In producing herewith one arrested accused person Ranjit Kr. Tudu (37Yrs), S/O- Bhagirath Tudu of Vill-Jamunabandh, PS - Boro, Dist - Purulia with seized 16 (Sixteen) sealed bottles in containing 375 ml each bottles styled as 'Dil khus' and 01 (one) bottle seized as sample from there as sell proceed from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that today (10/06/2022) during my evening mobile duty in between 20:15 hrs to 21.05 hrs acting on a secret source information I apprehended the above noted person in his house at Jamunabandh village and found that above noted person illegally stocked and selling 'Dil khus' to local public. On interrogation he disclosed his name and address as noted above. On demand he failed to produce any valid documents / License in respect of said illicit spirit which was kept in his house. Accordingly I seized 16 (Sixteen) sealed bottles in containing 375 ml each bottles styled as 'Dil khus' and 01 (one) bottle seized as sample from there as sell proceed under proper seizure list in presence of witnesses, which is enclosed herewith. As such he was arrested at 20.45 hrs u/s 46 A (C) B.E and during arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to the arrestee. Out of seized Dil khus' wine 375 ml taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd. Ranjit Kr. Tudu (37Yrs), S/O- Bhagirath Tudu of Vill-Jamunabandh, PS - Boro, Dist - Purulia violate section 18(i) B.E. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention and he committed offence u/s 46 A (C) B.E. Act. 1909.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Ranjit Kr. Tudu (37Yrs), S/O- Bhagirath Tudu of Vill-Jamunabandh, PS - Boro, Dist -Purulia.
