Sub: Prayer for lodged FIR,

Respected Sir,

In producing herewith one Tractor having Reg. No- WB55B-0846 with trolley loaded with approx 100 c.f.t sand, seizure lists, seized articles.

I beg to state that on 19.06.2022 myself along with (i) C/1246 Shaktipada Mahato, and (ii) C/974 Dilip Ghosh, were performing day mobile duty vide Boro PS GDE No. 751 Dtd-19.06.2022, C.C. No-1535./2022, Dtd: 19.06.2022, with Govt. vehicle Reg. No. WB 42S/4996. When we were going towards Chalka village side and reached near Kallabera tola Pry. School of Chalka village under Boro PS at about 11.15 hrs found one Tractor coming from chalka village sing para towards Khariduara Bridge more and seeing the Police party driver of the said vehicle kept the Tractor at the side of road and fled away from there. I along with force rushed to the spot and found one Tractor having Reg. No- WB55B-0846 with trolley loaded with approx 100 c.f.t sand and standing beside the pitch road. We searched for driver and owner of the Tractor but none turned up.

I conveyed the same to O/C Boro PS. I thoroughly search the nearby 2 KM areas in radius after placing guard for the vehicle. After that I came back and search for papers of the vehicle. All my efforts ended in smoke. I found no paper / documents relating to vehicle or loaded sand.

Accordingly I seized the Tractor having Reg. No- WB55B-0846 with trolley loaded with approx 100 c.f.t sand, under proper seizure list which has been duly signed by witness. The seizure was done in between 12.05 hrs to 12.25 hrs on 19.06.2022.

Held an enquiry about the matter and I went up Chalka village area in search of the driver. So far information collected it is crystal clear that the driver and the owner of the said dumper, in a trade of illegal trading of sand the sand. They were carrying the sand by illegal means with intent to make unlawful profit by unlawful collection of sand through illegal manner by removal of mines & minerals.

By this way they violated the regulation of procurement of sand. As such there is every reason to believe that the driver and owner of the said dumper with ill motive were transporting the sand illegally without any valid document in support of carrying sand. They violated the Govt. orders. As such they were doing illegal business activities.

Under the above facts and circumstances, I pray before you that kindly take needful action against the driver and owner of said dumper.
