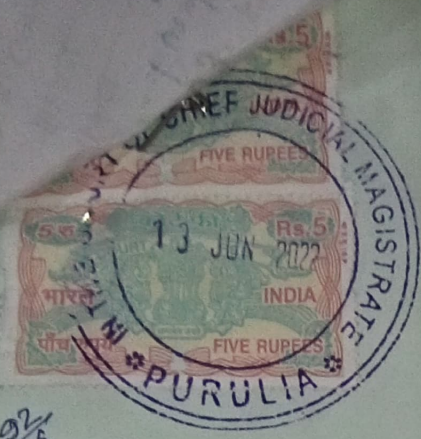

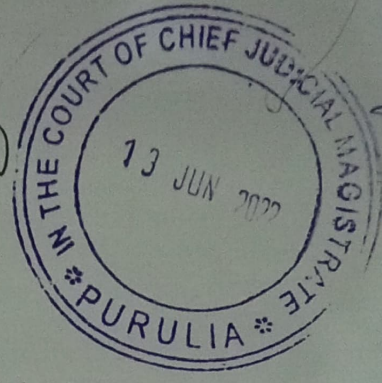

- 1) That the complainant is a resident of village- Ladhurka, P.S. Hura, Dist- Purulia.

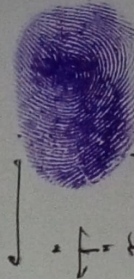
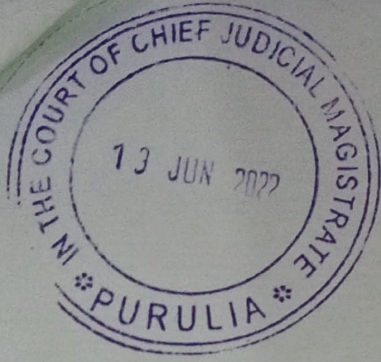

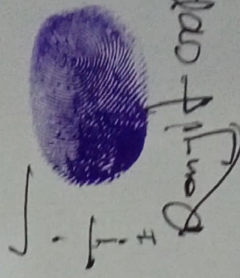
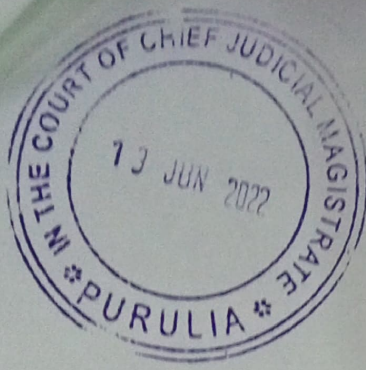
- 2) That a piece of land, i.e. the subject matter of the case is situated at mouza Ladhurka, under P.S. Hura, recorded as Hal Khata No. 78, Hal Plot no. 16, Area 20 decimals.
- 3) That the accused persons Kamala Kanta Kumbhakar, Robi Lochan Kumbhakar and Pramila Kumbhakar are the actual owner and legal possessor of the land mentioned hereinabove declared to sell the same and the complainant agreed to purchase the same and after due negotiation the complainant had paid a sum of Rs. 8,400/- to the said persons and the accused persons also receiving the consideration money i.e. Rs. 8,400/- and executed and registered one sale deed bearing no. 529 for the year 2008.
- 4) That it is to be mentioned herein that prior to execution and registration of the aforesaid sale deed one written agreement was prepared wherein it was fully mentioned in the said agreement.
- 5) That the complainant is an illiterate, rustic day labourer and not in a position of read and write and thereafter the complainant learnt that the said land in the deed has been mentioned 12 decimals instead of 20 decimals, then the complainant reported the matter to the aforesaid persons about such cheating.

- 6) That it may be mentioned herein that since the date of agreement though the complainant is possessing 20 decimals of the land, but presently the above noted accused Kamala Kanta Kumbhakar and Rabi Lochan Kumbhakar threatened the complainant by giving out on 15/05/2022 that they will not allow the complainant to possess 20 decimals of the land and accordingly the complainant being very much astonished as because the vendor of the land receive entire amount as mentioned herein above for the land i.e. of 20 decimals and agreement was prepared to that effect. In-spite of that the accused persons cheated the complainant for their personal gain and loss to the complainant and fully aware that they had to prepared the deed in respect of 20 decimals of the land as it was agreed in amongst the complainant and the accused persons.
- 7) That the accused persons committed various offences punishable under the Indian penal code for which he is deserved to be punished under the law.
- 8) That the matter was reported to the Officer-in-charge Hura P.S. against the accused persons, but the said Officer-in-charge did not taken any legal action against them, then the complainant lodged another complaint to the Superintendent of Police,
