I SI Gopal Bhattacharyya of Hura PS do hereby lodge the complaint against (1) Jamuna Bauri W/O- Kalipada Bauri, (2) Sandhya Bauri W/O- Nagar Bauri, (3) Putuna Bauri W/O- Sakhichand Bauri, (4) Jaba Banerjee W/O- Samir Banerjee (5) Sunita Bauri W/O- Ganesh Bauri (6) Susmita W/O- Piku Banerjee (7) Sadhana Majhi W/O- Abhijit Majhi (8) Susmita Mukharjee W/O- Piku Mukharjee all of Vill- Ladhurka (9) Pratima Gope W/O- Krishna Ch. Gope (10) Jahanara Bibi W/O- Jakir Ansary both of Chitra, PS- Hura, Dist- Purulia and others 40/50 male & female.

I beg to state that today (29.06.2022) while I was performing mobile duty along with force & Lady constable, which refers to Hura PS GDE No- 1275, Dtd- 29.06.2022 and at about 09:45 hrs. received a telephonic information that 40/50 male & female persons have blocked Bankura-Purulia NH60A road near Ladhurka more without any prior information and permission. After receiving the information I along with force rushed to the spot at about 10:05 hrs. and found that a large number of vehicle were obstructed at both side of Ladhurka more and 40/50 male & female persons had blocked the road. I asked them to disperse with loud and clear voice but they did not pay any heed to my words. I also tried to convince them but they did not pay any heed to my request. On being asked the above accused persons could not able to give any satisfactory answer for that movement on Purulia-Bankura NH60A road and blocked the public place. We started waiting and trying to convince them to clear the road for the interest of common people but our entire endeavor went air. They were willfully doing this blockade with an intention to injurious affect to the national highway causing esteem inconvenience to common people violating our order without having any order either from any concerned authority. By this way they blocked the road for 2 hours and at about 11:00 hrs. BDO Hura and others arrived at spot and after re-enforce and interference of BDO Hura at last they withdraw it at around 11:30 hrs. During enquiry I could be identified the above noted female persons and other could not be identified so far.

Therefore I am requesting you to start a specific case against the above noted female persons and others 40/50 male and female under proper section of law and arrange for its investigation.
